to the school commissioners for the use of the public schools in the respective counties where such licenses are issued, and of this amount the portion received from white tongers to go to the white schools, and the portion received from the colored tongers to go to the colored schools, and the remaining one-half to be paid over by the clerk to the Comptroller of the State Treasury, to be credited to the oyster fund; and one-half of the amount received from any tonging license in any county in this State shall be paid by the clerk of the circuit court of the county when received to the comptroller of the treasury to be credited to the oyster fund, any provisions of any public local law or public general law to the contrary notwithstanding.

If any person shall take oysters with rakes or tongs, for sale, without first having obtained a license as required by the preceding sections of this Article, he shall upon conviction thereof before a Justice of the Peace for the county wherein the offense has been committed be fined not less than twenty nor more than one hundred dollars and stand committed to the county jail till all costs and fines are paid. It shall be unlawful for any person taking oysters with rakes or tongs, for sale or otherwise, to use or have in his possession on any motor boat, any scrape, dredge or other device, and the possession of any such scrape, dredge or other device on any motor boat which may be used in the taking and catching of oysters, shall, and is hereby declared to be a misdemeanor, and the party upon conviction thereof before a Justice of the Peace for the county wherein the offense or violation occurred, or has been committed, shall be fined not less than the sum of two hundred dollars nor more than five hundred dollars, or shall be sentenced to confinement in the House of Correction for a term of not less than six months; and in any such case the boat or vessel used by him shall be forfeited, and may be condemned, in the discretion of the judge or justice of the peace, in the manner provided in Section 31. All persons taking or catching oysters under the provisions of this Article shall exhibit their authority for so doing when required by any ovster police force, or other officers of the State.

It shall be unlawful for any person or persons who have obtained a license to take or catch oysters with rakes or tongs to take or catch oysters in the waters of Queen Anne's, Talbot, Anne Arundel and Dorchester Counties, or in the waters of Kent County, exclusive of Swan Point Bar and the bar known as Lighthouse Lump northeast of Love Point Light House, or within one and a half miles of Sandy Point, Hackett's Point, Thomas' Point, Holland's Island Bar and Three Sisters and Holland's Point Bar with any implement or device other than ordinary rakes or tongs with wooden shafts, to be used entirely by hand, and without any ropes
