Upon complaint or allegation of any qualified voter of the City of Annapolis who shall give security for the costs of prosecution, that any license has been issued by said Mayor, Counselor and Aldermen to any person who shall not have complied with the provisions of this subtitle relating thereto, it shall be the duty of the State's Attorney for Anne Arundel County to file in the Circuit Court for said county, an information against said licensee, and if it shall be found that such license has been improperly issued said license shall be revoked.

Any person who shall be convicted of delivering distilled liquors or any admixture of distilled liquors containing more than fifteen per cent. of alcohol, to any person licensed to sell only fermented liquors, or liquors containing less than fifteen per cent. of alcohol, or upon the premises of such person, shall upon conviction be fined not less than one hundred dollars nor more than five hundred dollars, or be imprisoned in jail for not more than six months, or be both fined and imprisoned in the discretion of the court.
