be obtained shall have a collar put around his or her neck; and every dog or bitch found going at large in such town, not thus licensed, shall be shot or otherwise destroyed by the bailiff; and if any person shall bring a dog or bitch into the town after the month of April in any year, he shall obtain a license within ten days thereafter and pay for the same as hereinbefore directed, and place a collar around the neck of such dog or bitch, or otherwise said dog or bitch shall be shot or otherwise destroyed; any person failing or refusing to comply with the provisions of this section shall be liable to a fine of not less than one dollar for each dog and two dollars for each bitch brought or kept by him in said town, in addition to the penalty of having the same shot or otherwise destroyed if found going at large without a collar about his or her neck.

It shall be unlawful for any person or corporation to keep any hog or pig pen or sty within the corporate limits of the town of Centreville and any person or corporation violating the provisions of this section shall be deemed guilty of misdemeanor and upon conviction before any Justice of the Peace of the town of Centreville shall be fined not less than ten dollars nor more than fifty dollars for each and every offense, and shall be committed to the County Jail in default of the payment of said fine and costs.
