No person shall haul, cart, carry, drag or deposit any dead carcass or other carrion in Baltimore County, within one mile of the City of Baltimore, unless he shall bury, or cause the same to be buried at least two feet under ground, and so as effectually to prevent any offensive smell therefrom, under the penalty of twenty dollars for each offence, together with the expense of burying or removing the same.

Any person who shall remove or bury any dead carcass or offensive carrion, thrown out and deposited contrary to the provisions of the preceding section, shall recover, before any justice of the peace, against the person guilty of such offence, all expenses thereby incurred in burying and removing same.

Any person occupying any real property or chattels real in Baltimore County, either as tenant or owner thereof, or any person owning unoccupied real estate or chattels real in said county, who shall knowingly allow any dead carcass of any domestic animals to be exposed upon said premises without burial for a longer period than twenty-four hours, shall, upon presentment and conviction thereof, be deemed guilty of a misdemeanor, and shall be liable to a fine of twenty dollars or imprison-
