beer at any place within three-quarters of a mile in any direction of Public School No. 6, located at Halethorpe, in the Thirteenth Election District of Baltimore County, on what is known as Woodside Avenue therein, and that any person selling any spirituous or fermented liquors or lager beer or any kind of intoxicating drinks, whether of original manufacture or of a mixed character, within the above described limits shall, on conviction, be subject to the same fines and punishments now provided by the Code of General Laws of Maryland for selling spirituous or fermented liquors without a license.
