**121.** The school physicians shall be paid for the services rendered, such amount as the school authorities of the respective Counties shall deem proper and sufficient under the particular circumstances, and shall pay the same from the general funds in their hands, such compensation not to exceed \$2.00 per hour actually given to examinations in the schools.

**122.** The State Superintendent of Public Education shall prescribe, after consultation with the State Board of Health, the directions for tests of sight and hearing, and shall prescribe for the school authorities of the State suitable rules of instruction, test cards, blanks, record books, and other useful appliances for carrying out the purposes of this sub-title.

**123.** No person suffering from any communicable disease shall be employed as teacher or janitor in any public school in this State. At the opening of each annual term teachers must furnish a health certificate from a registered physician, addressed to the Superintendent of Schools, certifying that they are not suffering from tuberculosis or other communicable disease.
