### CONVEYANCING.<sup>1</sup>

#### Conveyances in General.

1. What estate shall not pass without deed duly acknowledged. Power of unmarried woman between 18 and 21 years of age to make deed of trust of her property. Proviso.
2. Power of unmarried woman over 18 years of age to convey redeemable ground rent.
3. Acknowledgments within county or city where real estate lies.
4. Acknowledgments within the state, but out of county or city where real estate lies.
5. Without the state.
