eighteen hundred and sixty-seven, and the first day of April, eighteen hundred and sixty-eight, respectively; the said amount of forty-five thousand dollars to be appropriated by the trustees to the liquidation of the present indebtedness of the said college and the purchase of furniture and apparatus for the said college; provided, the trustees of the said Mary-Ploviso. land Agricultural College, shall, on or before the first day of April, eighteen hundred and sixty-six, make, by a good and valid title, the state of Maryland equal joint owner of the property, of every kind and de-State to be made joint scription, real, personal and mixed, now owned by perty the said college.

146. Upon the acceptance of this act, by the Ibid s 2 majority of the stockholders, at a meeting to be authorized to called and held in pursuance of the act of incor-joint owner. poration, the trustees of said college are hereby authorized and fully empowered to make, by a good and valid title, the state of Maryland equal joint owner in all the property, of every kind and description, both real, personal and mixed, now owned by the said Maryland Agricultural College.

147. So much of the third section of the act of Ibid. 8 3 eighteen hundred and fifty-six, chapter ninety-seven, and 1888, c. 205, and the second section of the act of eighteen hundred and fifty-eight, chapter two hundred and sixty-five, which requires the board of trustees to consist of twenty-two trustees, one from each county, and one from the city of Baltimore, and authorizes the appointment of a trustee from the District of Columbia, and one from the Eastern Shore, and one from the Western Shore, for the state at large, is hereby repealed.
