said corporation, and showing their places of residence, the number of shares held by them respectively, and the time when they respectively became the owners of such shares, which book shall, during the usual business hours of every business day, be open for the in-Open to stock-holders and spection of stockholders or creditors of the corporation creditors at the principal office of the said corporation in this state; and every officer or agent of any such corporation who shall neglect or refuse to exhibit the same, shall be deemed guilty of a misdemeanor, and the corporation shall forfeit and pay to the party injured, a penalty of fifty dollars for every such neglect or re-penalty. fusal, and all the damages resulting therefrom to be recovered in an action of debt before a justice of the

peace.

68. It shall be the duty of every corporation formed Annual stateunder this article, having a capital stock, to cause to under oath be made in the first week in January and July in each and every year, a full and particular statement of the affairs of said company, verified by the oaths or affirmations of its President and Treasurer or chief finance officer, which statement shall consist of a particular account of its assets and liabilities in minute details. calculated to the time of making up the statement as Each of the said statements so made up To be recorded aforesaid. shall be recorded in a book kept in the principal office tion's office of the said corporation in this state.

69. Any corporation formed under this article, or How capital under the general laws of this state, or under any spe- or diminished. cial law, and having a capital stock, may increase or diminish the same to any amount that may be deemed sufficient and proper for the purposes of the corporation by complying with the provisions of the following sections, but every corporation incorporated under any corporation special law, which shall so increase or diminish its law capital stock, shall remain subject in other particulars to all the limitations contained in its charter, or in any supplement thereto; and every corporation incorporated under the general laws of this state, or under this article, which shall so diminish or increase its
