1874, c. 409, provides for the assessment of the shares of the capital stock of national banks located in this state, heretofore omitted to be assessed for state purposes; and for collecting the state taxes due on said shares.

1874, c. 238, an act to establish the Maryland house of correction, authorizes a tax of three-fourths of one cent on every one hundred dollars of taxable property to meet the interest, and to create a sinking fund for the redemption of the bonds directed to be issued by this act.

1868, c. 81, making valid the levy of the state tax made by the county commissioners of Allegany county for the year 1867.
