22. The county commissioners and Appeal Tax Court shall direct their clerk to enter and record in a book or books to be provided for property with alphabetical list the purpose, an accurate and fair account of all property of every sort within their county or city, and the valuation thereof, and an alphabetical list of the owners thereof properly arranged according to the election districts in the several counties, and according to the several wards in the city of Baltimore, which any person may inspect without fee or reward.
