MANURES AND FERTILIZERS.

32. All commercial manures and artificially manufactured or 1870, c 426, s 1 manipulated fertilizers, brought into or manufactured in the State of manufactures to be Maryland for sale and sold or kept for sale therein, shall have permanently affixed to every sack, bag, barrel, box, or other package thereof, a stamped or printed label, which shall specify legibly the name or names of the manufacturer or manufacturers, his, her or their place of business, the net weight of each sack, bag, barrel, box, or other package, the component parts of such manure or fertilizer. the percentage by weight, which it contains, of the following constituents, viz.: of phosphoric acid soluble in pure cold water, of phosphoric acid insoluble in pure cold water, of available ammonia, potash and soda.
