48. Every person who shall sell, or offer, or expose for sale, or who shall cause or procure to be sold, or offered or exposed for sale, any article or substance required by section forty-six hereof to be marked, branded, stamped, or labelled, not so marked, branded, stamped or labelled, shall be guilty of a misdemeanor, and on trial for such misdemeanor, proof of the sale or offer or exposure alleged, shall be presumptive evidence of knowledge of the character of the article so sold.

2. The county commissioners of each county shall, except where otherwise directed by the local law, on or before the first day of May in each year, appoint some person as keeper of the standards of weights and measures, who shall safely keep and preserve the same, and when required, deliver them to the county commissioners, or to such person as they may appoint to receive the same, and who shall perform the several duties prescribed by this article.
