21. In all cases of trials at common law, in said court, the parties, or either of them, who may except to the opinion of the court in the course of such trials, may require the court to sign and seal such exceptions before the verdict is rendered.

In all cases in said court, where, at the trial thereof, exceptions shall be taken to any opinion or opinions, direction or directions of the court, and an appeal or writ of error shall be taken or sued forth from or upon the judgment of the court, all the exceptions of all the parties, plaintiffs and defendants, that may have been taken, and whether the appeal or writ of error be taken or sued by all or any of said parties, shall be certified to the court of appeals as part of the transcript of the record to that court, and shall by said court be decided; and the decision of said court in the premises, if the cause be remanded to said circuit court, shall be accordingly certified to said circuit court.
