- Defendant to select property to be exempted; value, how ascertained.
- If indivisible, it shall be sold and \$100 of proceeds paid to defendant.
- Wearing apparel, text-books of mechanics and professional men, and tools and instruments of mechanics to be exempt.
- Sections 8-11 not to affect any lien of vendor, mortgagee or mechanic, nor to apply to taxes.
- 13. Exemption applicable only to actual residents of the State.
- 14. Exemption may be waived, and waiver enforced.

## Assignments to Non-Residents.

- 15. Assignment of claims to nonresidents for the purpose of foreign attachment or suit, so as to evade exemption laws of this State, to be unlawful; penalty.
- 16. Proof of assignment to be evidence of guilty intent.
- Copy of record of proceedings of foreign justice of the peace to be evidence.

## Sales in Bulk.

- 18. When sales otherwise than in ordinary course of business shall be deemed fraudulent unless made as directed by this section.
- 19. Rules of evidence not to be changed.
