39. Upon any appeal being taken in a court of law or equity, or application to take up the record as upon writ of error allowed, the clerk of such court shall make out, and transmit to the court of appeals, a transcript of the record of proceedings, under the seal of his office, in accordance with sections 6, 7, 12, 13, 31, 32, 33, 34 and 35, and within the time therein prescribed; and upon the receipt of such transcript, the clerk of the court of appeals shall enter the case upon his docket as of the term next after the receipt of such transcript.
