said county shall be received, and to fix the duties and compensation of all employees necessary to carry on said asylum.

SEC. —. After the erection of said asylum, all persons who have been heretofore determined in the Circuit Court for Allegany county to be insane paupers, and who shall be at the time said asylum is ready for use inmates of other institutions at the expense of said county, shall be removed to said asylum, and thereafter, whenever any person shall be found to be an insane pauper and dependent on said county, by inquisition in the Circuit Court thereof, said court shall commit said person to said asylum, and none other, unless the County Commissioners shall consent to his being sent to some other institution.

Court shall commit.

SEC. —. Said County Commissioners are hereby authorized to levy such sum annually upon the taxable property in said county as may be necessary to meet the running expenses of said asylum over and above its revenues, if any such deficiency be found to exist.

Authorized to levy.

Sec. —. For the purpose of raising the necessary funds to purchase the land and erect the building, or buildings, provided for in the foregoing sections, the commissioners of said county are hereby authorized to issue coupon bonds of said county in denominations of not less than one hundred nor more than five hundred dollars, and to an amount not exceeding thirty thousand dollars, said bonds to bear interest at the rate of six per cent. per annum, and to mature and fall due as follows, viz: five thousand dollars thereof at the end of five years from the date of issuing the same, and five thousand dollars at the end of each year thereafter until all are due; and said commissioners are authorized to dispose of said bonds at not less than par, and to devote the proceeds thereof to the purposes above mentioned; and the commissioners shall levy annually on the taxable property in said county a sum of money sufficient to pay the interest on said bonds, and shall levy
