 due to be paid unto the said Richard Farrowell his Heirs Executors Adm<sup>r</sup> or Assigns on or before the last  
 day of October next ensuing the date hereof, it being for a valuable Consideration already recd  
 to the whigg pay ment well & truly to be made & done. Given my self my Heirs Exors & Adm<sup>r</sup> & family  
 by these presents. In witness whereof I have hereunto sett my hand and seal this 26<sup>th</sup> day of July  
 Anno Domini 1690. The plant to be delivered at some Landing in Potomack River  
 Signed Sealed & delivered in the presence of us.
