This Indenture made the ^{king & Queen} thirteenth day of June in the second year of the Raigne of William & Mary of England Scotland France & Ireland defenders of the Protestant Religion And in the year of our Lord God one thousand six hundred & ninety Betweene John Emmit & Hannah his wife of Sommerset County in the Province of Maryland of the one Part And John Miller resident in y^e said County & Province of the other Part Witnesseth that whereas the R^o hon^oble Charles Lord & Proprietary of the Province of Maryland & Lord Baron of Baltimore or by his Deed of Graunt vnder the great seal used in the said Province of Maryland for granting of Land there bearing date at the City of St Marys the first day of June in the 12th year of Dominion or Amog^o do^m one thousand six hundred eighty and seven for the Consideration
