Francis wife to Thomas Williams. — & Gomey Sworn upon his holy Evangelists  
now with the following Depositions sent up to the Grand Jury upon their Oath  
affirming with this instrument following. — and — and

Swear by God the Father for their Master at a Grand Jury and for the body of this  
County at Mawson his Servant Tuesday in Gandy last past Gomey Sworn upon his holy  
Evangelists, etc present, & said that Thomas Williams aldimisfer within the  
jurisdiction of this Court next having the fear of God before his eyes, but by the  
Insigntion of the Devil, prompted by a wicked & abominable Luf wife and Mary —  
Derry his wifew of Cork found & late bries deportur. Sometime before the 15<sup>th</sup> in December  
Anno Domini 1693 did Comitt that most horrible & abominable Sin of Sodomy & other  
Begat a Bastard Child, wch in its own Nature is so odious & healefull to God & Man that if  
Lewdness made the Crime Capital. but the said Thomas Williams not satisfied with that  
unlawfull act of it selfe so horrious but aldimisfer after some time to see the  
same & goates of Derry as is above, did with bly & followenly intie Bedes Contract  
& Contract, to write the said Mary Derry to dispate, till & followenly to murder in said fruit  
or Cade of his other Goods Begotten, that it might not be known but Contract from the  
knowlage of all persons. As to the said Thomas the said Mary Derry did tamostnily carry into  
a Cobane henge at the Plantacion of the said Thomas, where he had beene  
themselves the said Mary was delivred, the Child most barbarously & unhumanely murthered  
thrown to the hedge in the poore Orphare to be devoured, not bairn slaying of said Infant  
a grab, for fear of suspicion. But God which syeth seeth & tryeth the hearts of all hearts and  
actions, would not permit or suffer so horrible & wch a sin to be unthorred or concealed  
the unratiously bring the same to light by Francis Williams, the wife of the said Thomas  
Williams, who upon the said 15<sup>th</sup> day of December 1693 did openly publicly of his parties  
with the said Thomas & Mary about 2000<sup>th</sup> yards at the hands of Michael Williams and
