Moses: Fenton. Lt } Somerset County Is. — Wm: Henderson late of  
Wm: Henderson. Lt } that County was summoned to answer unto Moses  
Fenton of a Debt y<sup>e</sup> he ownd to him three thousand  
foot of Cypress plant, whiche he ownd to him

And whereupon y<sup>e</sup> said Moses by Robert Dent his Attorney saith y<sup>e</sup> that  
said Wm: y<sup>e</sup> 19. day of gber in y<sup>e</sup> year of our Lord 1690, at Potomack within y<sup>e</sup> Jurisdiction  
of that Court by his Certain Dill Obligation, whiche the said Moses with the seal of y<sup>e</sup> said  
William signed brought here into Court. the date where of is the day & year aforesaid  
at & now doth himself to be justly indebted to the said Moses in y<sup>e</sup> full & just sum of 3000  
foot of Cypress plant to be paid to the said Moses at John: Hendersons Landing at or before  
the 10. day of December next ensuing the date of the said Dill, to whiche payment well  
and truly to be made, the said Wm bound himself by the said Dill. Notwithstanding y<sup>e</sup> said  
William. the said Debt to the said Moses hath not paid. to the damage of the said Moses  
6000. foot of plant & the rest of the things he brought into Court

Debt of Wm. Henderson to Moses Fenton  
6000. foot of Cypress plant

That Dill bindeth me William Henderson of Somerset County in the Province of Maryland or my  
Heirs Executors & Assigns to pay or cause to be paid unto Moses Fenton of the said County  
& Province aforesaid (whereunder himself his Executors or Assigns y<sup>e</sup> just sum or quantity of  
three thousand foot of Cypress plant to be paid John: Hendersons Landing at or before y<sup>e</sup> 10  
of December next ensuing the date hereof as witness my hand & seal this 19. day of gber  
1690.
