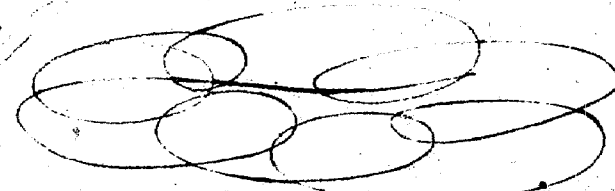


Somerset County in Maryland
