(a) The Board of County Commissioners of Allegany County are authorized, empowered and directed to levy and cause to be collected from the property owners, at the time of the County Tax Levy for the year 1948, or any succeeding vear, within said described area of Potomac Park Addition as created in this sub-title, such amounts not exceeding fifteen cents on each one hundred dollars' worth of assessable property in said part of the Potomac Park Addition, Allegany County, Maryland, as may be requested by a majority vote of the resident real estate owners of legal age, who are assessed as owners of real estate in such area present at a meeting called for such purpose by the Citizens' Committee hereinafter provided for, notice of which meeting shall have been mailed to all such resident owners at least two weeks in advance of the meeting.
