

- (52) \$35,000 Montgomery County Funding Bonds of 1934, Series B, dated May 15, 1934, issued under Chapter 25 of the Acts of 1933, Special Session, and maturing \$20,000 on May 15, 1938 and \$15,000 on May 15, 1939.
- (53) \$20,000 Montgomery County Funding Bonds of 1934, Series A, dated May 15, 1934, and issued under Chapter 25 of the Acts of 1933, Special Session, and maturing \$10,000 on May 15, 1938, and \$10,000 on May 15, 1939.
- (54) \$2,000 Thirteenth Election District Road Bonds, dated June 1, 1924, issued under Chapter 122 of the Acts of 1924, and maturing \$1,000 on June 1, 1938, and \$1,000 on June 1, 1939.
- (55) \$10,000 Montgomery County Court House Bonds, dated June 1, 1928, issued under Chapter 385 of the Acts of 1927, and maturing \$5,000 on June 1, 1938, and \$5,000 on June 1, 1939.
- (56) \$10,000 Montgomery County School Gymnasium Bonds, dated June 1, 1928, issued under Chapter 481 of the Acts of 1927, and maturing \$5,000 on June 1, 1938, and \$5,000 on June 1, 1939.
- (57) \$5,000 Montgomery County Court House Site Bonds, dated June 15, 1931, issued under Chapter 156 of the Acts of 1931, and maturing on June 15, 1939.
- (58) \$6,000 Montgomery County School Funding Bonds, dated June 15, 1931, issued under Chapter 193 of the Acts of 1931, and maturing \$3,000 on June 15, 1938, and \$3,000 on June 15, 1939.
- (59) \$16,000 Montgomery County Road Construction Bonds of 1931, dated June 15, 1931, issued under Chapter 194 of the Acts of 1931, and maturing \$4,000 on June 15, 1938, and \$12,000 on June 15, 1939. Provided, however, that if the assessable basis of the County for the fiscal year beginning July 1, 1938, and ending June 30, 1939, shall exceed the assessable basis of the County for the current fiscal year ending June 30, 1937, the amount of refunding bonds which may be issued hereunder for the purpose of refunding bonds described above which mature after June 30, 1938, shall be reduced by an amount equal to $1\frac{1}{2}\%$ of the amount by which the assessable basis of the County for the fiscal year beginning July 1, 1938 and ending June 30, 1939 exceeds the assessable basis of the County for the current fiscal year ending June 30, 1937.

SEC. 2. *And be it further enacted*, That said Board shall have full authority by resolution to carry out all of the powers conferred by this Act, and any such resolution shall be in force and effect from and after its passage.
