

troller for the use of the State before any such license is issued. No such license shall be issued for any place of business located in Montgomery County without the approval of the Board of License Commissioners for said County, and no such license shall be issued in Garrett, Kent, Talbot, Caroline and Somerset Counties.

21. *TWO LICENSES TO SAME PERSON PROHIBITED.* No more than one license provided by this Act, except by way of renewal, shall be issued to any person, or for the use of any partnership, corporation or unincorporated association, in Baltimore City or any County of the State, and no more than one license shall be issued for the same premises, except as provided in Section 3 and provided that in Baltimore City any person, firm or corporation operating more than one restaurant or hotel or more than one retail drug store at the time of the passage of this Act shall be entitled to obtain a license for each such place of business upon the filing of a separate application and the payment of a separate fee for each place of business.

Provided that the provisions of Section 21, restricting a licensee to one license, and that no more than one license shall be issued for the same premises, shall not apply to Charles County or Howard County, but in said Counties it shall be lawful for any licensee, by making application in the manner elsewhere described in this Act, to obtain both a beer (on sale) license, or a beer and light wine (on sale) license, and also a beer, wine and liquor (off sale), Class A license, upon compliance with other provisions of this Act, and upon payment of the fees herein prescribed for each class of license.

And provided further, that the holder of any wholesale license may, upon application, as hereinabove provided, apply for and obtain a beer, wine and liquor license, Class A, for a separate place of business from that designated in the wholesaler's license, but where the same person is the holder of both a wholesaler's and a Class A, beer, wine and liquor license, separate books of account shall be kept for each place of business, and the respective licenses shall otherwise be subject to all of the provisions of this Act.

And provided that in Calvert County it shall be lawful for any licensee, by making application in the manner elsewhere described in this Act, to obtain both a beer (on sale) license and also a beer, wine and liquor (off sale), Class A license, upon compliance with the provisions of this Act, and upon the payment of the fees herein prescribed for each class of license.

Every license shall be appropriately numbered by the official issuing the same.
