Gilbert's addition to Takoma Park then with the west side of a thirty foot right of way S 12' 14" E 311.03 feet, then S 42' 49" W 199.04 feet to an iron pipe in the last line of the whole tract then N 45' 17" W 495.82 feet to the beginning. Containing 116,739 square feet to 2.69 acres.

Beginning for the right of way strip at an iron pipe in the last line of the whole tract and 535.82 feet from the beginning thereof and running N 42' 49" E 208.95 feet to an iron pipe then N 12' 14" W 339.59 feet to the back line of Lot 55 Block 16 B. F. Gilbert's Addition to Takoma Park then running to include the western 30 feet of said lot 55 N 12' 34" W 217.3 ft. to Elm Avenue, then S 77' 26" W 30 feet to the corner of Lot 55 then S 12' 34" E 217.8 feet to an iron pipe then S 12' 14" E 311.03 feet, then S 42' 49" W 199.04 feet to an iron pipe in the last line of the Adam's tract then S 45' 17" E 40 feet to the beginning.
