

Confederation, 1781; a strong supporter of the Federal Constitution; he favored the electoral college, a national census, and an open economy; he opposed export taxes. **WEALTH DURING LIFETIME.** **PERSONAL PROPERTY:** 12 slaves, 5 servants, plus control of 46 slaves belonging to his mother who resided with him, 1776; combined assessed value with his mother £2,285.0.0, including 47 slaves and 100 oz. plate, 1783; assessed value alone £793.0.0, including 17 slaves and 183 oz. plate, 1796. **LAND AT FIRST ELECTION:** at least 7,607 acres in Frederick and Prince George's counties (3,850 acres inherited from his father and devised to him by his brother, John), plus several lots in Upper Marlboro, Prince George's County. **SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH:** acquired an additional 611 acres in Montgomery County, 1778–1794; deeded 778 acres as a gift to his son and sold 263 acres in Montgomery County, 1778–1794; acquired 627 acres in Prince George's County in 1796, probably at the death of his mother. **WEALTH AT DEATH.** **DIED:** on May 7, 1796, in Rock Creek, Montgomery County. **PERSONAL PROPERTY:** TEV, at least £2,802.3.2 (including 32 slaves). This figure incorporates the TEV of his mother, who shared his residence and predeceased him by 4 months. **LAND:** probably ca. 7,804 acres in Montgomery, Frederick, and Prince George's counties.

CARROLL, HENRY JAMES (ca. 1767–ca. 1814). **BORN:** ca. 1767, probably in St. Mary's County; eldest son. **NATIVE:** at least second generation. **RESIDED:** at "Susquehana Point," St. Mary's County; "Kingston Hall," Somerset County, ca. 1792. **FAMILY BACKGROUND.** **FATHER:** Capt. Henry Carroll (1727–1775), a mariner. **STEPFATHER:** George Biscoe. **MOTHER:** Araminta, daughter of Mary Thompson, of St. Mary's County, and heiress of *John Rousby* (1685–1744). **BROTHERS:** probably Michael; probably John Charles. **SISTERS:** Julian; Margaret; and Harriot. **MARRIED** on July 26, 1792, Elizabeth Barnes (1770–1826), daughter of Capt. *Thomas King* (?–?); granddaughter of *Robert King* (1689–1755). Her other relatives included great-grandfather *Robert King* (?–1697); great-aunts Mary King (1674–?), who married *Francis Jenkins* (ca. 1650–1710) and Eleanor King, who married *Charles Ballard* (ca. 1670–ca. 1724/25). **CHILDREN.** **SONS:** Thomas (1793–1873), governor of Maryland in 1830, who married Juliana Stevenson, of Baltimore County; Henry James; and Charles C. **DAUGHTER:** Elizabeth Mary. **PRIVATE CAREER.** **EDUCATION:** literate. **RELIGIOUS AFFILIATION:** Catholic; his

wife's family was Presbyterian. **OCCUPATIONAL PROFILE:** probably a planter. **PUBLIC CAREER.** **LEGISLATIVE SERVICE:** Lower House, St. Mary's County, 1789, 1790, 1791–1792, Somerset County, 1794, 1795, 1803. **LOCAL OFFICES:** justice, Somerset County, 1795—at least 1800; Maryland Senate elector, Somerset County, elected 1806 and 1811. **MILITARY SERVICE:** major, by 1802; inspector, Tenth Brigade (Somerset and Worcester counties), Maryland Militia, 1802–1809. **WEALTH DURING LIFETIME.** **PERSONAL PROPERTY:** assessed value £5,490.0.0, including 58 slaves and 180 oz. plate, 1813. **LAND AT FIRST ELECTION:** probably none. His father's land was in the name of his stepfather on the assessment of 1793, and Henry was listed as owning no land. **SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH:** inherited 170 acres of his father's land in St. Mary's County, by 1801; acquired 1,600 acres through his wife's inheritance in Somerset County, 1802. **WEALTH AT DEATH.** **DIED:** ca. 1814; his inventory was recorded on September 9, 1814, in Somerset County. **PERSONAL PROPERTY:** TEV, \$15,227.06 current money (including 58 slaves and 180 oz. plate); FB, \$3,971.64. **LAND:** at least 1,597 acres in Somerset and St. Mary's counties.

CARROLL, JAMES (MACCUBBIN) (1761–1832). **BORN:** on December 8, 1761, in St. Anne's Parish, Anne Arundel County; fourth son. **NATIVE:** at least fourth generation. **RESIDED:** in Annapolis until at least 1787; Baltimore County until death. **FAMILY BACKGROUND.** **FATHER:** Nicholas Maccubbin (1709–1787), of Annapolis, a merchant; son of Zachariah Maccubbin and wife Susanna Nicholson. **MOTHER:** Mary Clare, daughter of *Charles Carroll* (1691–1755). **UNCLE:** *Charles Carroll, Barrister* (1723–1783). **BROTHERS:** *Nicholas (Maccubbin) Carroll* (1750/51–1812), who married Ann (?–by 1839), daughter of *Thomas Jennings* (ca. 1736–1796); John Henry (1754–?); Charles (1756–?), who married Sarah Allen; and Samuel (1763–by 1784). **SISTERS:** Mary Clare (1749–1806), who married *John Brice* (1738–1820); Susanna (1757–?), who married Nicholas Lingan. **MARRIED** in December 1787 Sophia (1772–1816), daughter of *Harry Dorsey Gough* (ca. 1745–1808) and wife Prudence Carnan (?–1822); niece of Charles Ridgely, of "Hampton" (1760–1829), governor of Maryland, 1816–1819. **CHILDREN.** **SONS:** James, Jr.; Charles Ridgely; Harry Dorsey (1793–?), who married Elizabeth Ridgely (1797–1828); and John Gough (1811–1817). **DAUGHTER:** Prudence Gough. **PRIVATE CAREER.** **EDUCATION:** literate. **RELIGIOUS AFFILIA-**
