OCCUPATIONAL PROFILE: merchant; had an accounting house in Piscataway, Prince George's County. PUBLIC CAREER. LEGIS-LATIVE SERVICE: Lower House, Prince George's County, 1780-1781 (Claims 1, 2). LOCAL OFFICES: justice, Prince George's County, 1773-1792 (chief justice, by 1791); justice, Orphans' Court, Prince George's County, 1777-1782 ("desires to be left out"); purchasing agent, Prince George's County, appointed 1778 and 1779; subscription officer, Continental Loan Office, Prince George's County, appointed 1779. WEALTH DURING LIFETIME, PER-SONAL PROPERTY: 16 slaves, 1776; 40 slaves, 1790. LAND AT FIRST ELECTION: 500 acres in Prince George's County, plus 8 acres in Piscataway (all by personal acquisition), plus 308 acres in Prince George's County in his wife's name. SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: purchased 82 acres in Prince George's County in 1784 and ca. 300 acres in 1790 and 1791. Clagett acquired 914 acres in Prince George's County shortly before his death. WEALTH AT DEATH, DIED: on December 27, 1792, in Prince George's County. PERSONAL PROPERTY: TEV,

£3,627.6.2 current money (including at least 31 slaves, ca. 250 oz. plate, and 14 books); FB, £328.18.4. LAND: probably 1,766 acres in Prince George's County, plus lots in Piscataway, Prince George's County. IDENTIFICATION PROBLEMS. There are at least two other men by this name of age in 1780 in Prince George's County: Thomas Clagett, Sr. (?-ca. 1790), who was illiterate and died with an inventory valued at £702.0.0, and Thomas Clagett (1750-1790), son of Thomas Clagett, planter, who married Sarah White in 1785. Identification has been made on the basis of age, wealth, and political activity.

CLAIBORNE, WILLIAM (1600-ca. BORN: in 1600 in Crayford Parish, Kent, England: second son. IMMIGRATED: on Kent Island in 1627, but never settled permanently in Maryland, ADDI-TIONAL COMMENTS: brought three servants with him when he migrated to Virginia in 1621; he arrived in Virginia as a provincial officer and began acquisition of land in 1624; he led an expedition up the Chesapeake Bay in 1627 and established a trading base on Kent Island, which he actively developed in the next decade; he returned to England 1630-1631 and 1647-1650. FATHER: Thomas Clayborne (ca. 1557-1607), of Kent, England, the mayor of King's Lynn, Norfolk, England in 1592, and a merchant; son of Thomas Clayborne (?-1581), the mayor of King's Lynn, Norfolk, England in 1573, and a merchant.
