GOLDSBOROUGH, JOHN (1711-1778). BORN: on Friday, October 12, 1711, in Talbot County: fifth son. NATIVE: second generation. RESIDED: at "Four Square," Talbot County. FAMILY BACK-GROUND, FATHER: Robert Goldsborough (1660-1746). MOTHER: Elizabeth (1678-1719/20), daughter of Nicholas Greenberry (1627-1697). UNCLE: Charles Greenberry (1672-1713). HALF UNCLE: Thomas Robins (1672-1721). AUNT: Ann Greenberry, who married John Hammond (ca. 1665-1742/43).
