HALL, HENRY (1702/3-1756). BORN: on March 2, 1702/3, in St. James' Parish, Anne Arundel County; eldest son. NATIVE: second generation. RESIDED: at "Morley's Lott," South River, Anne Arundel County. FAMILY BACKGROUND. FATHER: Rev. Henry Hall (1676-1722), A.B., Cambridge University, 1697; immigrated in 1698 from Horsham, England, to become the first rector of St. James' Parish, Anne Arundel County. MOTHER: Mary (ca. 1682-?), daughter of Mareen Duvall (?-1694). BROTHERS: Benjamin (1706-1709); Benjamin (1710-1760), who married in 1731 Sophia Welsh; Edward (1714-1744), who married Mary Belt; John (1716-1790), who married in 1745

Anne Wells; and William (1719-1770), who married Rachel. SISTERS: Mary (1704-?), who married first, Gundar Erickson, and second, John Smith: Magdalene, who married Jonathan Davies; and Martha (1708-1752), who married in 1726 Stephen West (1682-1752).
