County as a gift from his father in 1780, and inherited 712 adjoining acres from his father in 1786; mortgaged 253 acres in 1795, 400 acres in 1797, and 250 acres in 1798, all in Kent County. Sold 150 acres in 1798 and 59 acres between 1801 and 1802, all in Kent County. Obtained a release of mortgage on 250 acres and sold 104 acres in 1802. Obtained a release of mortgage on 253 acres and sold 253 acres in 1807. Held no land in Kent County by 1815. WEALTH AT DEATH, DIED: on September 20, 1830, at William H. Tilghman's house near Tuckahoe Bridge, Talbot County; buried at "Cloverfields," Queen Anne's County. PER-SONAL PROPERTY: Inventory included only wearing apparel and one pair of steel-mounted spectacles. LAND: none. ADDITIONAL COMMENTS: Lloyd's marriage settlement in 1780 created a trust for Elizabeth so that if she survived him she would receive the real and personal estate James had received from his father instead of the usual widow's third. However, Elizabeth probably died before 1800 and the trust became moot. In the late 1790s Lloyd secured debts of over £1,500.0.0 specie in bonds and at least \$4,350.00 in promissory notes by mortgaging his land. These mortgages were later released.

MAR-RIED in 1669 Henrietta Maria (1647-1697), widow of Richard Bennett (ca. 1639-1667). She was the daughter of James Neale (ca. 1615-1684) and wife Ann. Her brothers were James; Anthony. Her sisters were Jane; Dorothy. CHILDREN. SONS: Edward Lloyd (1670-1718/19); Philemon Lloyd (ca. 1674-1732/33); and James Lloyd (1679/80-1723). STEPSON: Richard Bennett (1667-1749). LAND AT FIRST ELECTION: probably ca. 2,300 acres in Kent and Talbot counties. SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: patented an additional 4,800 acres and purchased at least 2,000 acres in Queen Anne's and Talbot counties. WEALTH AT DEATH. DIED: on June 22, 1685, in Talbot County. PER-SONAL PROPERTY: TEV, £4,305.16.7 sterling (including £1,198 in debts due the estate and £333.3.9 in bills of credit, 10 servants, 25 slaves, 186 oz. plate, and books); debts owed by the estate totalled £395.13.8 and 139,293 pounds of tobacco (as calculated). LAND: ca. 9,000 acres.
