ter County, Virginia, by 1652-1669; in Baltimore County, 1669-1676. FAMILY BACKGROUND. FATHER: Jeffrye (Geffrye) Todd (?-1637/38) of Denton, Durham County, a yeoman. MOTHER: Margaret. BROTHERS: Christopher (?-1680) of Denton, Durham County, who married in 1636 Jane Burden; John (1613-?). SISTER: Margaret, who married in 1625 George Runthwait, MARRIED probably by 1657 Anna (ca. 1638/39-by 1703), daughter of Rev. John Gorsuch (?-ca. 1647), rector of Walkhorne, Hertford, England, from at least 1633 until 1642, and wife Anne Lovelace (?-1652). Anne Lovelace Gorsuch emigrated to Virginia with seven of her children after her husband's death. Anna's brothers were Daniell (ca. 1629-?); John (ca. 1630-?); William (ca. 1631-?); Robert (ca. 1635-?); Richard (ca. 1637-?), who married Elizabeth Roe of Talbot County; Charles (ca. 1642-?), who married first, Ann Cole, and second, Ann Hawkins; and Lovelace (?-ca. 1703), who married first, in 1679, Rebecca, daughter of Richard Preston (ca. 1618-ca. 1669/70), and second, in 1696, Hannah Walley (?-1705). Her sisters were Katherine (1633-?), who married William Whitby (?-by 1655) of Virginia; Elizabeth (ca. 1641-?), who married by 1662 Howell Powell; and Frances. Anna Gorsuch Todd married second, ca. 1678, David Jones (?-1686/87), and third, by 1694, John Oldton (Ouldton) (?-1709). CHILDREN, SONS: Thomas (ca. 1660-1724/25), of Virginia, who married Elizabeth Bernard; John; Robert; and James (ca. 1670-1709), who married first, Elizabeth (last name unknown), and second, Penelope Scudamore. DAUGHTERS: Anne, who married ca. 1677 Miles Gibson (ca. 1646-1692); Johanna: Frances: and Averilla, PRIVATE CAREER. EDUCATION: literate, was apprenticed in England at the time of his father's will, 1637. RELIGIOUS AFFILIATION: probably Protestant, SOCIAL STA-TUS AND ACTIVITIES: Gent., upon arrival; sons held no known public office in Maryland. Oc-CUPATIONAL PROFILE: merchant; planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House. Baltimore County, 1674/75 (elected to the 4th session of the 1671-1674/75 Assembly). MILI-TARY SERVICE: captain, by 1669-death. WEALTH DURING LIFETIME. PERSONAL PROPERTY: held a share in the ship Augustine. LAND AT FIRST ELEC-TION: at least 1,700 acres in Maryland. WEALTH AT DEATH. DIED: in 1676, after April 11, possibly aboard a ship bound for England, or shortly after reaching England, PERSONAL PROPERTY: TEV, at least 95,419 pounds of tobacco (including 4 servants, 4 slaves, and books), plus at least £570.0.0 sterling in England mentioned in his will but not included in the inventories. LAND: at least 1,700 acres in Baltimore and Queen Anne's counties, plus land in England.

TOLLEY, THOMAS (?-1732). BORN: possibly in Kent County: of age by 1699. NATIVE: at least second generation. RESIDED: in Kent County by 1699-at least 1716; in Baltimore County by 1720. FAMILY BACKGROUND, FATHER: Walter Tollev (?-1699), a planter of Kent County. MOTHER: Elizabeth. BROTHERS: William; Walter; John; and George. SISTERS: Mary; Elizabeth. MARRIED by 1722 Mary (?-1733), daughter of Richard Freeborn (?-ca. 1719) of Baltimore County. Her sisters were Priscilla, who married in 1720 Samuel Howell: Elizabeth, who married in 1702 Garrett Garrettson; and Jane, who married in 1704 Robert Thomas. ADDITIONAL COMMENT: by 1709 Thomas Tolley was living with, but not married to, Mary Freeborn. He was repeatedly admonished for this by the vestry of St. Paul's Parish, Kent County, during the years from 1709 to 1716. Deponents in a later court case stated that all the children of Thomas Tolley and Mary Freeborn were born out of wedlock, except their youngest child James. CHILDREN. SONS: Thomas (?-1734); Walter Tolley (?-1783); and James (?-1744), who married Mary Watkins. DAUGHTERS: Mary; Elizabeth, who married Michael Miller. PRIVATE CA-REER. EDUCATION: literate. RELIGIOUS AFFILIA-TION: Protestant. SOCIAL STATUS AND ACTIVITIES: Gent., by 1709. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Baltimore County, 1722-1724, 1728-1731. LOCAL OFFICES: justice, Baltimore County, 1720-1732 (quorum, 1729-1732); coroner, Baltimore County, by 1723-at least 1724; commissioner, Joppa, appointed 1724; commissioner, Baltimore County, appointed to purchase land upon which Baltimore Town was to be built, 1729. WEALTH **DURING LIFETIME. LAND AT FIRST ELECTION: 885** acres in Baltimore County (all by purchase). Before he moved to Baltimore County. Tolley sold 966 acres in Kent County (at least 220 acres were inherited). SIGNIFICANT CHANGES IN LAND BE-TWEEN FIRST ELECTION AND DEATH: bought 1,553 acres in Baltimore County, plus a house and lot in Joppa, 1722-1732; sold 553 acres in Baltimore County, 1723-1731. WEALTH AT DEATH. DIED: between September 12 and October 9, 1732, in Baltimore County. PERSONAL PROPERTY: TEV,
