

GRATED: ca. 1740 from Accomack County, Virginia. His grandfather, Hendrick Waggaman (?–1682), probably immigrated to Virginia from Amsterdam by 1660. RESIDED: on “Waggaman’s Purchase” at the head of Great Monie Creek, Somerset County. Purported to have built his plantation “Monie” there. FAMILY BACKGROUND. FATHER: Jonathan Waggaman (?–1724) of Accomack County, Virginia. MOTHER: Margaret Eliot (Elliott), daughter of William Eliot of London. STEP-MOTHER: Comfort. BROTHERS: William Elliott (?–1747), a sea captain in the East India service, who died in Calcutta; Ephraim (?–1758), sheriff of Worcester County, 1752–1755, who married Mary Scott; and Jacob (?–1739), Gent., of Somerset County, who married Eleanor (last name unknown). MARRIED between 1739 and 1742 Mary (?–1780), daughter of Levin Woolford (1683–1721) and wife Sarah Jones (1691–?). Mary was the granddaughter of *Roger Woolford* (?–ca. 1701/2). She was the niece of *Roger Woolford* (1670–1730); Mary Woolford, who married *Henry Hooper* (ca. 1643–1720); Elizabeth Woolford (1664/65–1739), who married first, *Thomas Ennalls* (?–1718), and second, *William Holland* (?–1732); and Sarah Woolford (1672/73–by 1730), who married *Govert Lookerman* (ca. 1681–1728). Her sister was Martha, who married Samuel Wilson (?–1748). Her first cousins were *James Woolford* (ca. 1736–ca. 1783); *Thomas Woolford* (ca. 1699–ca. 1750/51); *Henry Hooper* (ca. 1687–1767); Mary Hooper (1674–1745), who married *Henry Ennalls* (1675–1734); Elizabeth Hooper, who married *Matthew Travers* (ca. 1672–1742); Anne Hooper, who married *John Broome* (1676–ca. 1738/39); Mary Hooper (?–ca. 1757), who married second, *John Rider* (1686–1739/40); and Sarah Lookerman (?–by 1745), who married *Joseph Cox Gray* (?–1764). Her nephew was *Levin Wilson* (1735–1791). CHILDREN. SONS: John Elliott (?–by 1767); William Elliott, a planter of Somerset County; George (?–by 1801), Gent., of Somerset County; and *Henry Waggaman* (1753–1809). DAUGHTERS: Sarah, who married in 1770 Isaac Outten (1748–?); Elizabeth, who probably married (first name unknown) Footman; and Mary (?–1760). PRIVATE CAREER. EDUCATION: literate; left detailed instructions for the education of his sons in his will. RELIGIOUS AFFILIATION: Presbyterian, Manokin Presbyterian Church, Somerset County. SOCIAL STATUS AND ACTIVITIES: Gent., by 1741. OCCUPATIONAL PROFILE: mariner, by 1742; merchant, by 1752; owned at least one schooner, 1753. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Somerset

County, 1749–1751 (Bills of Credit 1), 1751–1754 (Accounts 1–6), 1754–1757 (Accounts 5, 6), 1757–1758 (Accounts 1, Cv, 2), 1758–1760 (Accounts Cv 1, 1, Cv 2; died prior to the beginning of the 3rd Convention of the 1758–1761 Assembly). LOCAL OFFICES: elder, Manokin Presbyterian Church, Somerset County, 1748, 1749, 1753; justice, Somerset County in office 1746–1760 (quorum 1755–1760); justice, Court of Oyer, Terminer, and Gaol Delivery, appointed 1753 (quorum, 1753). MILITARY SERVICE: captain, by 1745; called major, 1759. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: 1,298 acres in Somerset County (1,061 acres by patent, of which 384 acres had been inherited by his wife from her mother; 237 acres through purchase). Inherited 500 acres of land in Accomack County, Virginia, from his father in 1724, but it had been sold by 1746. SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: purchased 1,010 acres, plus lot 14 in Princess Anne Town, all in Somerset County, 1750–1758; patented 1,112 acres, 1753–1754, and sold 300 acres, 1756, all in Somerset County. WEALTH AT DEATH. DIED: between December 11, 1760, and April 15, 1761, in Somerset County. PERSONAL PROPERTY: TEV, £5,738.17.4 current money (including 13 slaves, 73 books, and 49 oz. plate); FB, £5,634.19.2. LAND: 3,120 acres and lot 14 in Princess Anne Town, all in Somerset County.

WAGGAMAN, HENRY (1753–1809). BORN: in 1753 in Monie Hundred, Somerset County. NATIVE: second generation. RESIDED: maintained residences at “Monie,” at the head of Great Monie Creek, Monie Hundred, Somerset County, until at least 1788, and at “Fairview,” Upper District, Dorchester County, from ca. 1785 until death. FAMILY BACKGROUND. FATHER: *Henry Waggaman* (?–ca. 1761). MOTHER: Mary Woolford (?–1780). BROTHERS: John Elliott (?–by 1767); William Elliott; and George (?–by 1801). SISTERS: Sarah; Elizabeth; and Mary (?–1760). FIRST COUSIN: *Levin Wilson* (1735–1791). MARRIED on May 3, 1780, Sarah (1761–1842), daughter of *Thomas Ennalls* (?–by 1783) and wife Mary Sulivane. Sarah was the niece of *Daniel Sulivane* (1745/46–1799); *Henry Ennalls* (ca. 1741–by 1788); and Margaret Ennalls (?–by 1795), who married *William Maynardier* (1747–1795). CHILDREN. SONS: Thomas Ennalls (1782–1832), who married Martha Jefferson, daughter of Judge John Tyler (1747–1813), a governor of Virginia, and his wife Mary Armistead; Henry (1784–1784); George Augustus (1790–1843), a lawyer of Caroline County, and a U.S.
