

in Somerset County; patented 360 acres in Somerset County (now Sussex County, Delaware); probably purchased ca. 250 acres in Prince George's County. **WEALTH AT DEATH.** DIED: petition to probate will filed in Prince George's County on February 14, 1728/29. **PERSONAL PROPERTY:** TEV, £424.14.9 current money (including 8 slaves, 3 indentured servants, and 60 oz. plate); FB, estate overpaid £79.1.7. **LAND:** 1,280 acres in Somerset County and ca. 250 acres in Prince George's County.

WALKER, PHILIP (?–1791). BORN: after 1740, probably in Dorchester (later Caroline) County. NATIVE: second generation. RESIDED: in Dorchester (later Caroline) County. **FAMILY BACKGROUND.** FATHER: Philip Walker (?–1776), an Anglican minister who was licensed to Maryland on March 25, 1756. He received the bounty on April 8, 1756, and was appointed to All Hallow's Parish, Anne Arundel County, on May 4, 1760. On October 12, 1760, he was appointed to St. Mary's, Whitechapel Parish, Dorchester County. Walker was also a merchant. MOTHER: Elizabeth (?–by 1756), widow of Anthony Richardson, daughter of James Dickinson (?–1738) and wife Hannah Coale. AUNTS: Mary Dickinson (?–by 1765), who married *Pollard Edmondson* (ca. 1718–1794); Ann Dickinson (?–ca. 1774), who married *Samuel Bowman* (?–1768). HALF BROTHERS: Anthony Richardson; Thomas Dickinson Richardson (1740–?). SISTERS: Anne (?–by 1787), who married first, Andrew Mein, second, Edward Hindman (?–1781), and third, *Henry Dickinson* (?–1789); Elizabeth (?–1783), who married *Henry Dickinson* (?–1789). FIRST COUSIN: (first name unknown) Edmondson, who married *Christopher Birckhead* (by 1740–1788). MARRIED first, (first name unknown) Dickinson, daughter of William Dickinson (?–1754), Gent., of Talbot County and wife Mary Ann Bozman (ca. 1715–1775). She was the stepdaughter of Thomas Loveday and the granddaughter of *Thomas Bozman* (ca. 1693–1752). MARRIED second, on December 5, 1780, Margaret, daughter of Charles Dickinson (?–1779) and wife Sophia Richardson. Her brothers were *Henry Dickinson* (?–1789); *John Dickinson* (ca. 1726–1789). Her sister was Sidney, who married Thomas Loockerman (?–1753). Her first cousin was *William Richardson* (1735–1825). Her nephew was *Thomas Wynn Loockerman* (?–1801). CHILDREN. DAUGHTERS: Nancy (Anne), who married John Dickinson. WARD: Andrew Mein. **PRIVATE CAREER.** EDUCATION: literate. RELIGIOUS AFFILI-

ATION: probably Anglican. **OCCUPATIONAL PROFILE:** planter. **PUBLIC CAREER.** LEGISLATIVE SERVICE: Lower House, Caroline County, 1786–1787, 1787–1788, 1790. LOCAL OFFICES: coroner, Caroline County, 1778–1791; commissioner of the tax, Caroline County, commissioned 1782, 1783, 1785, 1786, and 1790. **WEALTH DURING LIFETIME.** **PERSONAL PROPERTY:** assessed value £623.0.0, including 15 slaves and 71 oz. plate, 1783. **LAND AT FIRST ELECTION:** 800 acres in Caroline and Talbot counties (700 acres inherited from his father). **SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH:** purchased 120 acres in Caroline County, 1786–1790. **WEALTH AT DEATH.** DIED: between January 21 and May 5, 1791, in Caroline County. **PERSONAL PROPERTY:** TEV, £2,197.4.8 current money (including 23 slaves and books); FB, £1,690.6.0. **LAND:** 920 acres in Caroline and Talbot counties.

WALLACE, CHARLES (1727–1812). BORN: on April 27, 1727, in St. Anne's Parish, Anne Arundel County. NATIVE: at least second generation. RESIDED: in Annapolis, Anne Arundel County (in the Tasker/Dulany mansion on Market Street, 1793 to at least 1804); also maintained a country estate in Anne Arundel County by at least the early 1800s. **FAMILY BACKGROUND.** FATHER: John Wallace of Annapolis. MOTHER: Anne. SISTERS: probably at least two, including Mary (?–1797), who married Cornelius Howard (1728–1771). NIECE: Rebecca Howard (1758–1806), who married *Alexander Contee Hanson* (1749–1806). MARRIED first, Catherine (ca. 1731–1795), sister of Mary, who probably married (first name unknown) Cummings. MARRIED second, on April 26, 1798, Mary (ca. 1747–1834), widow of George Rankin (?–ca. 1783), daughter of Constantine Bull of Norwich, Norfolk County, England, and wife Catherine Walker of Northrop Hall, near Dallam, Yorkshire, England. A Constantine Bull resided in Maryland from at least 1748 until at least 1772, and could have been either Mary's father or brother. Mary Bull Rankin was living in Annapolis by 1784, when she advertised for pupils to learn reading, needlework, and lacework. In 1788 she declared herself an insolvent debtor. Mary and Charles Wallace signed a marriage agreement on April 25, 1798, in which Mary agreed to give up her right of dower to Wallace's property in return for his house, plate, furniture, slaves, £2,000.0.0, and an allowance of £200.0.0 per year for life if she survived him. CHILDREN. SONS: possibly included Charles, who married in
