

in Kent County. PERSONAL PROPERTY: £330.0.7 current money (including 1 servant, 4 slaves, and books); FB, £298.0.0. LAND: ca. 1,745 acres in Queen Anne's and Kent counties mentioned in his will.

WARD, HENRY (?-ca. 1683/84). IMMIGRATED: in 1665, as a free adult. RESIDED: in Baltimore (later became Cecil) County; in New Castle, Delaware, 1676; returned to Cecil County by 1679. MARRIED first, Mary. MARRIED second, Anna Margretta, daughter of Augustine Herman (?-1686) and wife Jane. Her brothers were Ephraim (ca. 1651-1689); *Casparus Augustine Herman* (1656-1697). Her sisters were Judith, who married first, *John Thompson* (?-1701/2), and second, John Dowdell (?-1728); Francina (ca. 1662-?), who married Joseph Wood. Her nephews were *Joseph Wood* (?-1738); *Ephraim Augustine Herman* (1683-1734/35); *Richard Thompson* (ca. 1680-1775); and *Augustine Thompson* (1691-1738/39). Her niece was Augustina Herman, who married first, *Thomas Frisby* (1681-ca. 1715/16), and second, *Roger Larramore* (?-1721). Anna Margretta subsequently married by ca. 1686 *Matthias Vanderheyden* (?-1729). CHILDREN. SON: *Henry Ward* (?-1734), who married Elizabeth, daughter of *William Pearce* (ca. 1641-1720/21). DAUGHTER: Rebecca (?-1695). PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: probably Protestant. SOCIAL STATUS AND ACTIVITIES: Mr., by 1676; travelled often to Barbadoes and England. The Assembly passed an act of punishment against Ward and fined him 4,000 pounds of tobacco for entering a false claim for money allegedly due him from the public levy, 1676. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Cecil County, 1674/75 (elected to the 4th session of the 1671-1674/75 Assembly when Cecil County was established, Laws 4). LOCAL OFFICES: deputy surveyor, Baltimore County, 1670; justice, Baltimore County, 1672-1674, Cecil County, 1674-1676, 1679-1683/84 (quorum). MILITARY SERVICE: captain, by 1682. OUT OF COLONY SERVICE: justice, New Castle, Delaware, 1676. WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: at least 1,900 acres in Cecil County (1,366 acres acquired through his second marriage). SIGNIFICANT CHANGES IN LAND BETWEEN FIRST ELECTION AND DEATH: acquired an additional 1,900 acres in Cecil County between 1682 and 1684. WEALTH AT DEATH. DIED: by February 10, 1683/84. PERSONAL PROPERTY: TEV, £631.13.0 and 52,817 pounds of

tobacco (including 5 servants, 10 slaves, and more than 30 books); FB, £487.0.0. LAND: ca. 3,800 acres in Cecil County.

WARD, HENRY (?-1734). BORN: in Cecil County; only son. NATIVE: second generation. RESIDED: in Cecil County. FAMILY BACKGROUND. FATHER: *Henry Ward* (?-ca. 1683/84). STEPFATHER: *Matthias Vanderheyden* (?-1729). MOTHER: Anna Margretta, daughter of Augustine Herman (?-1686) and wife Jane. UNCLE: *Casparus Augustine Herman* (1656-1697). AUNT: Judith Herman, who married first, *John Thompson* (?-ca. 1701/2). SISTER: Rebecca (?-1695). HALF SISTERS: Jane Vanderheyden; Francina Vanderheyden, who married second, *Charles Hynson* (1692-1748); Augustina Vanderheyden, who married *James Harris* (1682-1743); Ariana Vanderheyden (1690-?), who married first, *James Frisby* (1684-1719), second, *Thomas Bordley* (ca. 1683-1726), and third, *Edmund Jennings* (?-1756). FIRST COUSINS: *Joseph Wood* (?-1738); *Ephraim Augustine Herman* (1683-1734/35); Augustina Herman, who married first, *Thomas Frisby* (1681-ca. 1715/16), and second, *Roger Larramore* (?-1721); *Richard Thompson* (ca. 1680-1775); and *Augustine Thompson* (1691-1738/39). MARRIED Elizabeth, daughter of *William Pearce* (ca. 1641-1720/21) and wife Isabella. Her brothers were Gideon (1678-1751); William (?-1703); Benjamin (1683-1734); and *Daniel Pearce* (1677-1727). Her sisters were Isabella, who married first, *William Blay* (ca. 1681-1716); Sarah. Her niece was Rachel Blay (1703-1746), who married first, *Edward Scott* (?-1725), and third, *Aquila Paca* (ca. 1703-1743/44). CHILDREN. DAUGHTER: Margaret (1716-?), who married *Benjamin Pearce* (1711/12-1756). PRIVATE CAREER. EDUCATION: literate. RELIGIOUS AFFILIATION: Anglican, probably North Sassafras Parish, Cecil County. SOCIAL STATUS AND ACTIVITIES: second generation burgess, Gent., by 1710. OCCUPATIONAL PROFILE: planter. PUBLIC CAREER. LEGISLATIVE SERVICE: Lower House, Cecil County, 1711 (elected to the 4th session of the 1708B-1711 Assembly). LOCAL OFFICE: justice, Cecil County, by 1723-1734 (quorum, 1730-1734). WEALTH DURING LIFETIME. LAND AT FIRST ELECTION: ca. 3,800 acres in Cecil County inherited from his father, plus 600 acres purchased in 1710. WEALTH AT DEATH. DIED: buried on May 9, 1734; St. Stephen's Church, North Sassafras Parish, Cecil County. PERSONAL PROPERTY: TEV, £833.5.0 current money (including 8 slaves); FB, £808.9.3. LAND: ca. 3,800 acres in Cecil County.
