YOUNG, JOHN (?-ca. 1731/32). BORN: at Road (Rhode) River, Anne Arundel County. NATIVE: at least second generation. RESIDED: in St. Mary's County by 1724-ca. 1731/32. **FAMILY BACKGROUND.** FATHER: *Samuel Young* (ca. 1662-1736). MOTHER: Mary, daughter of *Robert Clarkson* (?-1666), stepdaughter of *Richard Hill* (ca. 1640-1700). BROTHERS: Joseph (?-1737); Richard (1693-1748); Samuel (1702-died at age 12 months); Henry (1703-died at age 6 months); and Samuel (1704-1743). SISTER: Sarah (?-1738). NIECE: Mary Young, who married first, in 1755. *Henry Woodward* (1733-1761). MARRIED probably Mary (?-by 1737), who was probably the daughter of *John Leech* (ca. 1663-1713). Her brothers were probably John; Samuel (?-ca. 1732/33). Her sisters were probably Margaret; Alice; and Elizabeth. **CHILDREN.** DAUGHTERS: Mary, who married Pollard Keene of Baltimore County; Elizabeth, who married John Keene of Baltimore County. **PRIVATE CAREER.** EDUCATION: probably literate. RELIGIOUS AFFILIATION: Protestant. SOCIAL STATUS AND ACTIVITIES: Esq., by 1720. OCCUPATIONAL PROFILE: probably planter. **PUBLIC CAREER.** LEGISLATIVE SERVICE: Lower House, St. Mary's County, 1728-1731. **WEALTH DURING LIFETIME.** LAND AT FIRST ELECTION: at least 150 acres in St. Mary's County (all by purchase). **WEALTH AT DEATH.** DIED: administration bond filed on February 19, 1731/32, in St. Mary's County. **PERSONAL PROPERTY:** TEV, £480.13.0 current money (including 7 slaves); FB, £391.10.9. **LAND:** probably at least 150 acres in St. Mary's County.

YOUNG, NICHOLAS (?-1669/70). IMMIGRATED: in 1656, as a free adult. RESIDED: in St. Mary's County. MARRIED Elizabeth (?-1695/96), widow of Edward Parker (?-1644). **CHILDREN.** STEPSONS: Edward Parker (?-1669/70); Samuel Parker; and Philip Parker. STEPDAUGHTER: Elizabeth Parker. **PRIVATE CAREER.** EDUCATION: literate. RELIGIOUS AFFILIATION: probably Catholic. SOCIAL STATUS AND ACTIVITIES: Gent., by 1667. OCCUPATIONAL PROFILE: probably planter. **PUBLIC CAREER.** LEGISLATIVE SERVICE: Lower House,

St. Mary's County, 1666 (Laws). LOCAL OFFICES: justice, St. Mary's County, 1663/64-1666, 1668-1669/70 (quorum, 1665-1666, 1668-1669/70); sheriff, St. Mary's County, 1666-1667. **MILITARY SERVICE:** captain, 1665/66-1669/70. **WEALTH DURING LIFETIME.** LAND: patented 60 acres in Charles County. **WEALTH AT DEATH.** DIED: between January 11 and January 29, 1669/70, in St. Mary's County. **LAND:** 60 acres in Charles County and rights to a tract in St. Michael's Hundred, St. Mary's County (acreage unknown).

YOUNG, SAMUEL (ca. 1662-1736). BORN: ca. 1662, probably in England. IMMIGRATED/NATIVE: unknown. RESIDED: on Rhode River, Anne Arundel County. **FAMILY BACKGROUND.** BROTHER: Richard, who was still alive in 1742. MARRIED on July 14, 1687, Mary (?-ca. 1723), widow of Maj. Thomas Francis (?-ca. 1686), daughter of *Robert Clarkson* (?-1666) and wife Milcah. Mary was the stepdaughter of *Richard Hill* (ca. 1640-1700). Her brother was Robert. Her half brothers were *Joseph Hill* (ca. 1670-1724); Richard Hill (1673-1729); and Henry Hill. Her sister was Elizabeth. **CHILDREN.** SONS: *John Young* (?-ca. 1731/32); Richard (1693-1748), clerk of Calvert County, 1718-1744, who married in 1737 Rebecca, daughter of *Thomas Holdsworth* (ca. 1692-1718); Joseph (?-1737), who married first, (name unknown), and second, Araminta, widow of *Ephraim Augustine Herman* (1683-1734/35); Samuel (1702-1703); Henry (1703-died in infancy); and Samuel (1704-1743), who married Rebecca Boyce Cockshutt. DAUGHTER: Sarah (?-1738), who married first, in 1719, George Budd, and second, in 1737, Edward Fottrell (?-1741/42). **PRIVATE CAREER.** EDUCATION: literate. RELIGIOUS AFFILIATION: Anglican; wife's family was Quaker. SOCIAL STATUS AND ACTIVITIES: precise origins uncertain, but may have been native born; first appearance in Maryland records occurs at the time of his marriage; perhaps related to London merchants Samuel and Timothy Young, who traded in Maryland in the 1670s, or to Sarah Leigh Young, who married second, by 1650. *Samuel Waring* (ca. 1618-1671), and third, by 1674/75, John Hance (?-1708/9); Gent., by 1695; Esq., by 1705. OCCUPATIONAL PROFILE: merchant, by 1687; planter. **PUBLIC CAREER.** LEGISLATIVE SERVICE: Lower House, Anne Arundel County, 1697/98-1700 (Laws 3; Elections and Privileges 4), 1701-1704, 1704-1707; Upper House, 1708A, 1708B-1711, 1712-1714, 1715, 1716-1718, 1719-1721/22, 1722-1724, 1725 (no evidence of service after the 1st
