The bulk of the records required to write the biographies of the men who governed Maryland from 1635 through 1789 are located at the Hall of Records, although other repositories were searched for relevant materials. Since our travel funds were limited we occasionally intruded upon vacation itineraries, suggesting stops at archives or historical societies. When a senior staff archivist accompanied her husband to Philadelphia, where he was to participate in a champion-ship tennis tournament, we persuaded her that visiting the City Bureau of Archives and History and the Historical Society of Pennsylvania would be more absorbing than watching her husband attempt to vanquish his cross-court foe. On another occasion, a staff member's sister made a trip from her upstate New York home to Kentucky, and we prevailed upon her to spend a diverting day or so at the Kentucky Division of Archives and Records, locating probate materials on Maryland legislators.

The holdings of the Maryland State Library and the Maryland Historical Society were frequently consulted. The collections at the Virginia State Library, Archives Division, the Virginia Historical Society, and the Research Department of the Colonial Williamsburg Foundation were rich in reference materials on men who served in the Maryland General Assembly prior to 1715. Other information was secured from the Library of Congress, the Milton S. Eisenhower Library of The Johns Hopkins University, the North Carolina State Division of Archives and History, the Kentucky Historical Society, the Filson Club, the University of Pennsylvania Archives and Records Center, Princeton University Library, the William R. Perkins Library at Duke University, the Nicholas Murray Butler Memorial Library at Columbia University, and Yale University Library. We found relevant documents in London at the Public Record Office, the British Museum, the Institute of Historical Research, the Friends' House Library, and the Lambeth Palace Library; in Edinburgh, at the Scottish Record Office and the National Library of Scotland; and in Paris, at the French National Archives, where Jean Baker ably acted as translator and guide. At all of these institutions we received the most courteous attention, for which we are grateful.

Undoubtedly in such a cooperative enterprise a few names will remain obscured through oversight. A project of this nature, involving the collaboration of so many people, inevitably results in omissions when writing acknowledgments. To those we have inadvertently forgotten we extend our apologies and our sincere appreciation.
