GOVERNMENTAL, SCIENTIFIC, EDUCATIONAL, OR PROPRIETORIAL PROPRIETARY PURPOSE.

- (4) "RESEARCH FACILITY" MEANS ANY ENCLOSURE OR SEPARATELY SECURED YARD, PAD, POND, LABORATORY, PASTURE, OR PEN THE PURPOSE OF WHICH IS TO CONDUCT RESEARCH, HOUSE RESEARCH SUBJECTS, OR STORE SUPPLIES, RECORDS, DATA, PROTOTYPES, OR EQUIPMENT NECESSARY TO OR DERIVED FROM THE RESEARCH PROCESS.
- (B) A PERSON WHO BREAKS AND ENTERS A RESEARCH FACILITY IS GUILTY OF A FELONY, AND UPON CONVICTION SHALL BE SENTENCED TO NOT MORE THAN 10 YEARS IMPRISONMENT OR A FINE OF \$10,000 OR BOTH.
- (5) "RESEARCH PROPERTY" MEANS ANY PROPERTY RELATED TO RESEARCH IN A RESEARCH FACILITY, REGARDLESS OF VALUE, INCLUDING ANY SAMPLE, SPECIMEN, RESEARCH SUBJECT, RECORD, DATA, TEST RESULT, OR PROPRIETARY INFORMATION.
- (C) (B) A PERSON SHALL BE GUILTY OF BREAKING AND ENTERING A RESEARCH FACILITY ONLY IF THE ENTRY:
- (1) THE BREAKING AND ENTERING WAS PERFORMED WITH THE INTENT TO:
- (1) OBTAIN UNAUTHORIZED CONTROL OVER ANY PROPERTY, SAMPLE, SPECIMEN, RESEARCH SUBJECT, RECORD, DATA, TEST RESULT, OR PROPRIETARY INFORMATION IN THE RESEARCH FACILITY;
- (2) ALTER OR ERADICATE ANY SAMPLE, PROPERTY, SPECIMEN, RESEARCH SUBJECT, RECORD, DATA, TEST RESULT, OR PROPRIETARY INFORMATION IN THE RESEARCH FACILITY;
- (3) DAMAGE, DEFACE, MOVE, DESTROY, OR REMOVE ANY SAMPLE, PROPERTY, RESEARCH SUBJECT, RECORD, DATA, TEST RESULT, OR PROPRIETARY INFORMATION IN THE RESEARCH FACILITY REGARDLESS OF VALUE; OR
- (4) ENGAGE IN CONDUCT THAT RESULTS IN THE REMOVAL OF ANY PROPERTY FROM THE RESEARCH FACILITY.
- (I) OBTAIN UNAUTHORIZED CONTROL OVER RESEARCH PROPERTY;
 - (II) ALTER OR ERADICATE RESEARCH PROPERTY;
- (III) <u>DAMAGE</u>, <u>DEFACE</u>, <u>OR MOVE IN A MANNER INTENDED</u> <u>TO CAUSE HARM TO RESEARCH PROPERTY</u>, <u>OR DESTROY OR REMOVE</u> <u>RESEARCH PROPERTY</u>; <u>OR</u>
 - (IV) ENGAGE IN CONDUCT THAT RESULTS IN THE
