(5) IF ~~A~~ THE DISTRICT COURT ISSUES AN ORDER OF RESTITUTION UNDER THIS SECTION, THE CLERK OF THE DISTRICT COURT SHALL FORWARD A WRITTEN NOTICE TO THE INDIVIDUAL, GOVERNMENTAL ENTITY, OR THIRD PARTY PAYOR TO WHOM A DEFENDANT HAS BEEN ORDERED TO PAY RESTITUTION ~~WHICH STATES THAT THAT STATES:~~

(I) THE ORDER OF RESTITUTION DOES NOT CONSTITUTE A MONEY JUDGMENT UNTIL IT IS ~~INDEXED AND RECORDED~~ RECORDED AND INDEXED AS SUCH IN THE CIVIL JUDGMENT RECORDS IN THE DISTRICT COURT;

(II) THE ORDER OF RESTITUTION ~~WILL~~ SHALL BE ~~INDEXED AND RECORDED~~ RECORDED AND INDEXED AS A MONEY JUDGMENT IN THE DISTRICT COURT AND A NOTICE OF LIEN ~~WILL~~ SHALL BE FORWARDED TO THE CIRCUIT COURT OF THAT COUNTY BY THE CLERK OF THE DISTRICT COURT ~~UPON~~ ON THE RECEIPT OF A WRITTEN STATEMENT FROM THE INDIVIDUAL, GOVERNMENTAL ENTITY, OR THIRD-PARTY PAYOR ~~REQUESTING THAT THAT REQUESTS~~ THE ORDER OF RESTITUTION BE ~~INDEXED AND RECORDED~~ RECORDED AND INDEXED AS A MONEY JUDGMENT;

(III) A NOTICE OF LIEN ~~WILL~~ SHALL BE FORWARDED BY THE CLERK OF THE DISTRICT COURT TO ANY OTHER CIRCUIT COURT ~~UPON~~ ON THE RECEIPT OF A WRITTEN STATEMENT FROM THE INDIVIDUAL, GOVERNMENTAL ENTITY, OR THIRD-PARTY PAYOR ~~REQUESTING THAT THAT REQUESTS~~ THE NOTICE OF LIEN BE FORWARDED TO A SPECIFIC CIRCUIT COURT; AND

(IV) THERE ~~WILL~~ SHALL BE NO FEE FOR ~~INDEXING AND RECORDING~~ RECORDING AND INDEXING THE ORDER OF RESTITUTION AS A MONEY JUDGMENT IN THE DISTRICT COURT OR FOR ~~INDEXING AND RECORDING~~ RECORDING AND INDEXING A NOTICE OF LIEN IN THE CIRCUIT COURT OF THAT COUNTY.

(J) A COURT MAY NOT ASSESS ANY COSTS ON AN INDIVIDUAL, GOVERNMENTAL ENTITY, OR THIRD-PARTY PAYOR TO WHOM A DEFENDANT HAS BEEN ORDERED TO PAY RESTITUTION:

(1) FOR ~~INDEXING AND RECORDING~~ RECORDING AND INDEXING AN ORDER OF RESTITUTION AS A MONEY JUDGMENT IN THE COURT IN WHICH THE ORDER OF RESTITUTION WAS ISSUED; OR

(2) FOR ~~INDEXING AND RECORDING~~ RECORDING AND INDEXING A NOTICE OF LIEN FORWARDED BY ~~A~~ THE DISTRICT COURT TO ~~THE A~~ A CIRCUIT COURT OF THE COUNTY IN WHICH THE DISTRICT COURT IS LOCATED.
