- (6) the University of Maryland System; [and]
- (7) for a procurement under Title 3, Subtitle 4 of this article, the Department of Budget and Fiscal Planning; AND
- (8) FOR A PROCUREMENT IN CONNECTION WITH CONSTRUCTION OF A STATE CORRECTIONAL FACILITY UNDER § 12-107 OF THIS ARTICLE, THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES.

Article 41 - Governor - Executive and Administrative Departments 4-104.1.

- (A) (1) THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL ADVISE THE BOARD OF PUBLIC WORKS IN CONNECTION WITH ANY ENGINEERING QUESTION OR MATTER CONCERNING CONSTRUCTION OF A STATE CORRECTIONAL FACILITY.
- (2) THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL SUPERVISE ANY ENGINEERING QUESTION OR MATTER CONCERNING THE DESIGN OR CONSTRUCTION OF A STATE CORRECTIONAL FACILITY.
- (3) ANY CONTRACT, PLAN, <u>DESIGN</u>, OR SPECIFICATION FOR CONSTRUCTION OF A STATE CORRECTIONAL FACILITY THAT INVOLVES AN ENGINEERING QUESTION IS SUBJECT TO THE APPROVAL OF THE SECRETARY OF PUBLIC SAFETY AND CORRECTIONAL SERVICES.
- (4) EXCEPT THAT ARCHITECTURAL AND ENGINEERING SERVICES SHALL BE PROCURED UNDER TITLE 13, SUBTITLE 3 OF THE STATE FINANCE AND PROCUREMENT ARTICLE OF THE CODE, THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL APPROVE ALL ARCHITECTURAL AND ENGINEERING DESIGNS AND OTHER ARCHITECTURAL AND ENGINEERING SERVICES IN CONNECTION WITH THE CONSTRUCTION OF A STATE CORRECTIONAL FACILITY.
- (B) THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL:
- (1) REPRESENT THE BOARD OF PUBLIC WORKS AT THE OPENING OF BIDS FOR CONTRACTS RELATED TO CONSTRUCTION OF A STATE CORRECTIONAL FACILITY;
 - (2) TABULATE AND RECORD THE BIDS; AND
 - (3) ADVISE THE BOARD OF PUBLIC WORKS ON THE BIDS.
- (C) THE DEPARTMENT OF PUBLIC SAFETY AND CORRECTIONAL SERVICES SHALL EXAMINE AND APPROVE OR DISAPPROVE EACH PLAN DESIGN, PLAN, AND SPECIFICATION PREPARED IN CONNECTION WITH THE PREPARATION OR EXECUTION OF A CONTRACT FOR
