- (II) THE SECRETARY OF BUDGET AND FISCAL PLANNING OR THE SECRETARY'S DESIGNEE;
- (III) THE SECRETARY OF PERSONNEL OR THE SECRETARY'S DESIGNEE;
- (IV) THE INSURANCE COMMISSIONER OR THE COMMISSIONER'S DESIGNEE;
- (V) THE DIRECTOR OF FISCAL SERVICES OR THE DIRECTOR'S DESIGNEE;
- (VI) THE DIRECTOR OF LEGISLATIVE REFERENCE OR THE DIRECTOR'S DESIGNEE 3 EXECUTIVE BRANCH MEMBERS APPOINTED BY THE GOVERNOR;
- (VII) 1 MEMBER (II) 2 MEMBERS OF THE SENATE DESIGNATED BY THE PRESIDENT OF THE SENATE; AND
- (VIII) 1 MEMBER (III) 2 MEMBERS OF THE HOUSE OF DELEGATES DESIGNATED BY THE SPEAKER OF THE HOUSE.
- (3) EACH OFFICIAL APPOINTED UNDER PARAGRAPH (2)(I) OF THIS SUBSECTION MAY APPOINT A DESIGNEE.
- (3) (4) (I) WITH THE CONCURRENCE OF NOT FEWER THAN 5 4 MEMBERS, THE COMMITTEE SHALL APPOINT AN EXECUTIVE DIRECTOR AS PROVIDED IN THE STATE BUDGET.
- (II) STAFF SUPPORT FOR THE COMMITTEE SHALL BE PROVIDED BY THE RESPECTIVE AGENCIES ON THE COMMITTEE.
- (C) (1) AT THE REQUEST OF THE GOVERNOR OR THE LEGISLATIVE POLICY COMMITTEE, THE INTERDEPARTMENTAL COMMITTEE SHALL EVALUATE LEGISLATIVE PROPOSALS OR STATUTES THAT ESTABLISH, EXPAND, OR REPEAL MANDATED HEALTH INSURANCE BENEFITS OR, EXCEPT AS OTHERWISE PROVIDED BY LAW, NONDISCRIMINATION PROVISIONS, AND BENEFICIARY OR LENGTH OF COVERAGE PROVISIONS.
- (2) BY APRIL 30 MAY 31 OF EACH YEAR, THE GOVERNOR OR THE LEGISLATIVE POLICY COMMITTEE SHALL NOTIFY THE COMMITTEE AS TO WHICH EVALUATIONS SHALL BE CONSIDERED AT MADE BEFORE THE ENSUING REGULAR SESSION OF THE GENERAL ASSEMBLY.
- (3) NOTHING IN THIS SECTION SHALL AFFECT THE ABILITY OF THE GENERAL ASSEMBLY TO ENACT LEGISLATION ON MANDATED HEALTH INSURANCE BENEFITS OR, NONDISCRIMINATION PROVISIONS, AND BENEFICIARY OR LENGTH OF COVERAGE PROVISIONS.
