FOR the purpose of authorizing the creation of a State Debt in the amount of Two Hundred Fifty Five Million, Five Hundred Twenty Five Thousand Dollars (\$255,525,000) Two Hundred Forty Five Million, Three Hundred Fifty Nine Thousand, Seven Hundred Fifty Dollars (\$245,359,750) Two Hundred Forty-Three Million, Four Hundred Sixty-Five Thousand, Four Hundred Two Dollars (\$243,465,402), the proceeds to be used for certain necessary building, construction, demolition, planning, renovation, conversion, replacement, and equipment purposes of this State, and for acquiring certain real estate in connection therewith, and for grants to certain subdivisions and other organizations for certain purposes subject to the requirement that the grantees provide certain matching funds of a certain type by a certain date; providing generally for the issuance and sale of bonds evidencing the loan; amending Chapter 671 of the Acts of 1977, the General Construction Loan of 1977, as amended by Chapter 420 of the Acts of 1979, the General Construction Loan of 1979, to permit funds appropriated for a Fire Rescue Services Building to be used to design and construct a station house for the College Park Volunteer Fire Department; amending Chapter 795 of the Acts of 1978, the General Construction Loan of 1978, as amended by Chapter 125 of the Acts of 1985, the General Construction Loan of 1985, to permit funds remaining in the appropriation to demolish Old Dining Hall and Woodshop at the Maryland Penitentiary to be used to provide a portion of the funds to design, construct, and equip additional housing at Patuxent Institution and Central Laundry Pre-Release Unit; amending Chapter 420 of the Acts of 1979, the General Construction Loan of 1979, to permit funds remaining in the appropriation for the renovation of "B" cell block in West Wing at the Maryland Penitentiary to be used to provide a portion of the funds to design, construct, and equip additional housing at Patuxent Institution and Central Laundry Pre-Release Unit; amending Chapter 693 of the Acts of 1980, the General Construction Loan of 1980, to permit funds remaining in the supplemental appropriation for the construction of a correctional facility of 500 beds to be used to provide a portion of the funds to design, construct, and equip additional housing at Patuxent Institution and Central Laundry Pre-Release Unit; amending Chapter 520 of the Acts of 1982, the General Construction Loan of 1982, to permit a portion of the funds remaining in the supplemental appropriation for acquisition of the Latrobe Site, and construction of a 250-bed minimum security unit to be used to provide a portion of the funds to design, construct, and equip additional housing at Patuxent Institution and Central Laundry Pre-Release Unit; amending Chapter 670 of the Acts of 1983, the General Construction Loan of 1983, to permit funds remaining in the appropriation to restore the exterior wall and roof of the main Dining Room, Officer's Dining Room and Kitchen Building, and the roof of the State Use Industries Warehouse at the Maryland House of Correction to be used to provide a portion of the funds to design, construct, and equip additional housing at Patuxent Institution and Central Laundry Pre-Release Unit; amending Chapter 670 of the Acts of 1983, the General Construction Loan of 1983, as amended by Chapter 286 of the Acts of 1986, the General Construction Loan of 1986, to permit funds remaining in the appropriation to design, prepare detailed plans and specifications for, and construct a 192-bed maximum-security housing unit at the
