Article - Commercial Law

14-2101.

(a) (1) In this section the following words have the meanings indicated.

{(2) "Collision damage waiver" means any contract, whether separate from or part of a rental agreement, in which the lessor agrees, for a charge, to waive all or part of any claims against the lessee for damages to the rental motor vehicle during the term of the rental agreement.}

~~(2) "AUTHORIZED DRIVER" MEANS:~~

~~(I) THE LESSEE;~~

~~(II) THE LESSEE'S SPOUSE IF THE SPOUSE IS A LICENSED DRIVER AND MEETS THE LESSOR'S MINIMUM AGE REQUIREMENTS;~~

~~(III) THE LESSEE'S EMPLOYER OR AN EMPLOYEE OF THE LESSEE'S EMPLOYER;~~

~~(IV) ANY PERSON WHO OPERATES THE RENTAL MOTOR VEHICLE IN AN EMERGENCY;~~

~~(V) ANY PERSON THAT PARKS A RENTAL MOTOR VEHICLE AT A COMMERCIAL ESTABLISHMENT WITH THE LESSEE'S PERMISSION; AND~~

~~(VI) ANY PERSON SPECIFIED AS AN AUTHORIZED DRIVER IN THE RENTAL AGREEMENT.~~
