~~(E) (1) IN THE EVENT OF DAMAGE TO A RENTAL MOTOR VEHICLE FOR WHICH AN AUTHORIZED DRIVER IS RESPONSIBLE UNDER SUBSECTION (B) OF THIS SECTION AND IS NOT COVERED BY AN AUTOMOBILE INSURANCE POLICY, THE LESSOR SHALL CHARGE NO MORE THAN THE ACTUAL COST PAID BY THE LESSOR IN REPAIRING SUCH VEHICLE.~~

~~(2) IF THE DAMAGED VEHICLE CANNOT BE REPAIRED BECAUSE PARTS NECESSARY TO EFFECT THE REPAIR ARE NOT AVAILABLE WITHIN A REASONABLE PERIOD OF TIME, THE RENTAL MOTOR VEHICLE COMPANY MAY CHARGE NO MORE THAN THE AMOUNT IN THE STANDARD MOTOR CRASH GUIDE, OR SIMILAR INSURANCE INDUSTRY CRASH GUIDES.~~

~~(F) UPON WRITTEN REQUEST FROM THE AUTHORIZED DRIVER OR SUCH AUTHORIZED DRIVER'S REPRESENTATIVE, INCLUDING AN INSURER, THE RENTAL VEHICLE COMPANY AND ITS REPRESENTATIVES SHALL IDENTIFY THE REPAIRER OF, AND PROVIDE ACCESS TO, THE DAMAGED VEHICLE, IN ORDER TO VERIFY THE NATURE AND EXTENT OF DAMAGES, REPAIRS, AND REPAIR COSTS, EXCEPT THE RIGHT TO ACCESS PROVIDED HEREIN SHALL EXPIRE AFTER 10 BUSINESS DAYS FOLLOWING THE AUTHORIZED DRIVER'S RECEIPT OF NOTIFICATION FROM THE LESSOR.~~
