

ADMINISTRATOR IS NOT A RESIDENT OF CECIL COUNTY, THE COUNTY ADMINISTRATOR SHALL BECOME A COUNTY RESIDENT WITHIN FOUR (4) MONTHS AFTER APPOINTMENT.

4-3. QUALIFICATIONS.

A. A COUNTY ADMINISTRATOR SHALL BE SELECTED ON THE BASIS OF MERIT, EDUCATION AND APPROPRIATE EXPERIENCE.

B. A COUNTY ADMINISTRATOR SHALL HAVE:

(1) A BACHELOR'S DEGREE IN PUBLIC ADMINISTRATION OR AN EQUIVALENT DEGREE FROM AN ACCREDITED COLLEGE OR UNIVERSITY; AND

(2) A MINIMUM OF THREE (3) YEARS' EXPERIENCE IN PUBLIC SECTOR ADMINISTRATION.

4-4. DUTIES AND POWERS.

THE COUNTY ADMINISTRATOR SHALL:

A. SUPERVISE AND IMPLEMENT THE POLICIES AND INSTRUCTIONS OF THE BOARD OF COUNTY COMMISSIONERS AS THE BOARD DIRECTS;

B. SERVE AS LIAISON OFFICER BETWEEN COUNTY DEPARTMENTS AND AGENCIES AND THE BOARD OF COUNTY COMMISSIONERS; AND

C. HAVE ADDITIONAL POWERS AND DUTIES AS PRESCRIBED BY THE BOARD.

4-5. REMOVAL FROM OFFICE.

NOTWITHSTANDING § 4-2 OF THIS CHAPTER, THE BOARD OF COUNTY COMMISSIONERS MAY REMOVE A COUNTY ADMINISTRATOR AFTER GIVING THE COUNTY ADMINISTRATOR AT LEAST THIRTY (30) DAYS' NOTICE.

CHAPTER 6  
AIRPORT AUTHORITY

6-1. CREATION OF AUTHORITY.

THE BOARD OF COUNTY COMMISSIONERS OF CECIL COUNTY MAY CREATE AN AIRPORT AUTHORITY OF CECIL COUNTY, WITH THE MEMBERS, POWERS, DUTIES, FUNCTIONS AND OPERATIONS PROVIDED IN THIS SECTION.

6-2. COMPOSITION; TERMS; CHAIRMAN; RESIDENCY MEMBERS.

IF CREATED, THERE SHALL BE FIVE (5) MEMBERS OF THE AUTHORITY, TO BE SELECTED AND APPOINTED BY THE BOARD OF COUNTY COMMISSIONERS OF CECIL COUNTY. OF THE MEMBERS FIRST
