

APPOINTED TO THE COMMISSION, ONE (1) SHALL BE APPOINTED FOR AN INITIAL TERM OF ONE (1) YEAR, ONE (1) FOR AN INITIAL TERM OF TWO (2) YEARS, ONE (1) FOR AN INITIAL TERM OF THREE (3) YEARS, ONE (1) FOR AN INITIAL TERM OF FOUR (4) YEARS AND ONE (1) FOR AN INITIAL TERM OF FIVE (5) YEARS. AS THESE INITIAL TERMS EXPIRE THE TERMS OF SUCCEEDING MEMBERS SHALL BE FOR FOUR (4) YEARS EACH. THE BOARD SHALL APPOINT PERSONS TO THE AUTHORITY WHO ARE SKILLED AND PROFICIENT IN THE GENERAL SUBJECT OF AVIATION AND AIRPORTS. THE BOARD, FROM TIME TO TIME, SHALL DESIGNATE A CHAIRMAN OF THE AUTHORITY. ALL MEMBERS OF THE AUTHORITY AT THE TIME OF APPOINTMENT AND DURING THEIR SERVICE ON THE AUTHORITY SHALL BE RESIDENTS OF CECIL COUNTY. THE AUTHORITY SHALL MEET REGULARLY TO CARRY OUT ITS FUNCTIONS UNDER THIS SECTION.

6-3. AUTHORITY TO STUDY NEED AND POSSIBILITY OF AN AIRPORT.

THE AIRPORT AUTHORITY SHALL STUDY THE NEED AND POSSIBILITIES FOR AN AIRPORT IN CECIL COUNTY, THE RULES, REGULATIONS, AND REQUIREMENTS OF THE FEDERAL AVIATION COMMISSION AND THE STATE AVIATION ADMINISTRATION IN RELATION TO ANY SUCH FACILITY, THE POSSIBILITIES FOR OBTAINING STATE OR FEDERAL FUNDS FOR THE CONSTRUCTION AND OPERATION OF AN AIRPORT, POSSIBLE SITES FOR AN AIRPORT, AND SUCH OTHER MATTERS AS PROPERLY ARE RELATED TO, AND FALL WITHIN THE SCOPE OF, THE INTENT AND PURPOSE OF THIS SECTION.

6-4. REPORTS AND RESULTS OF STUDIES.

FROM TIME TO TIME, THE AIRPORT AUTHORITY SHALL REPORT TO THE BOARD OF COUNTY COMMISSIONERS AND TO THE CITIZENS OF CECIL COUNTY THE RESULTS OF ITS STUDIES AND DELIBERATIONS, TOGETHER WITH ANY SUMMARIZED INFORMATION IT MAY COMPILE AND WITH SUCH RECOMMENDATIONS AS IT MAY THINK FEASIBLE AND PROPER FOR THE PROGRESS AND DEVELOPMENT OF AVIATION AND AIRPORTS IN CECIL COUNTY.

6-5. AIRPORT OR AIRPORTS TO BE UNDER CONTROL OF AUTHORITY.

FOLLOWING SUCH STUDIES, THE BOARD OF COUNTY COMMISSIONERS MAY ESTABLISH AND CONSTRUCT AN AIRPORT OR AIRPORTS IN CECIL COUNTY, UNDER THE PROVISIONS OF THIS CHAPTER. IN THAT EVENT, IT OR THEY SHALL BE OPERATED AND MAINTAINED UNDER THE CONTROL, DIRECTION, AND SUPERVISION OF THE AIRPORT AUTHORITY.

6-6. FUNDS AND GRANTS.
