SUPERVISE THE CONSTRUCTION AND MAINTENANCE OF COUNTY ROADS AND BRIDGES.

- (3) ALL BILLS PRESENTED FOR PAYMENT FOR WORK ON COUNTY ROADS AND BRIDGES SHALL BE OPEN TO PUBLIC INSPECTION DURING OFFICE HOURS UNDER THE DIRECTION OF AN EMPLOYEE OF THE OFFICE OF THE BOARD OF COUNTY COMMISSIONERS.
- (4) THE BOARD OF COUNTY COMMISSIONERS SHALL PROVIDE FOR INSPECTION OF ANY CONSTRUCTION OR REPAIRS OF COUNTY ROADS AND BRIDGES AS SOON AS POSSIBLE AFTER THE CONSTRUCTION OR REPAIRS ARE COMPLETE. THE BOARD MAY NOT APPROVE A BILL FOR CONSTRUCTION OR REPAIRS UNTIL THERE HAS BEEN FULL COMPLIANCE WITH THE CONTRACT FOR THE CONSTRUCTION OR REPAIRS.

## 15-4. SALARY AND EXPENSES.

- A. THE BOARD OF COUNTY COMMISSIONERS SHALL RECEIVE A SALARY OF THIRTY THOUSAND DOLLARS (\$30,000.) PER YEAR.
- B. IN ADDITION, EACH MEMBER OF THE BOARD OF COUNTY COMMISSIONERS OF CECIL COUNTY SHALL RECEIVE THE BENEFITS AND REIMBURSEMENTS FOR REASONABLE EXPENSES IN THE PERFORMANCE OF DUTIES AS PROVIDED IN THE CECIL COUNTY BUDGET OR BY LAW, INCLUDING, WHERE APPROPRIATE:
- (1) REIMBURSEMENTS UNDER THE STANDARD STATE TRAVEL REGULATIONS; AND
- (2) PARTICIPATION IN THE HEALTH CARE PLAN THAT IS NEGOTIATED FOR COUNTY EMPLOYEES.
- C. THEY SHALL RECEIVE TWO THOUSAND DOLLARS (\$2,000.) PER YEAR TO COVER EXPENSES, EXCEPT THAT THE PRESIDENT OF THE BOARD SHALL RECEIVE AN ADDITIONAL FIVE HUNDRED DOLLARS (\$500.).
- D. IN ADDITION, FOR ALL MILEAGE EXPENSES AND OTHER EXPENSES RELATED TO COUNTY BUSINESS, EACH COMMISSIONER SHALL SUBMIT A VOUCHER TO THE COUNTY TREASURER FOR REIMBURSEMENT.
- 15-5. AUTHORITY OF CLERK TO ADMINISTER OATH OR AFFIRMATION.

THE CLERK TO THE BOARD OF COUNTY COMMISSIONERS IS AUTHORIZED AND EMPOWERED TO ADMINISTER AN OATH OR AFFIRMATION TO ANY PERSON FILING IN THE OFFICE OF THE BOARD A CLAIM AGAINST THE COUNTY, OR OTHER PAPER TO WHICH AN AFFIDAVIT MAY BE REQUIRED BY LAW, OR BY ORDER OF THE BOARD TO ANY PERSONS WHO ARE TO BE EXAMINED AS WITNESSES IN ANY
