E. ANY MEMBER OF A BODY WHO WILLFULLY PARTICIPATES IN ANY MEETING WHICH VIOLATES THIS CHAPTER, KNOWING THE MEETING TO CONSTITUTE SUCH A VIOLATION, OR ANY PERSON WHO WITHHOLDS RECORDS KNOWING SUCH WITHHOLDING OF RECORDS CONSTITUTES A VIOLATION, IS GUILTY OF A MISDEMEANOR PUNISHABLE UPON CONVICTION BY A FINE OF NOT MORE THAN FIVE HUNDRED DOLLARS (\$500.).

CHAPTER 55 ORDINANCES AND RESOLUTIONS

- 55-1. CUSTODIAN; MINUTES; INDEXING ADMISSIBLE AS EVIDENCE.
- A. THE CLERK TO THE BOARD OF COUNTY COMMISSIONERS OF CECIL COUNTY SHALL BE OFFICIAL CUSTODIAN OF ALL ACTS, ORDINANCES AND RESOLUTIONS ADOPTED OR PASSED BY THE COUNTY COMMISSIONERS.
- B. ACTS, ORDINANCES, AND RESOLUTIONS SHALL BE INDEXED BY PAGE NUMBER IN THE OFFICIAL MINUTES OF THE BOARD OF COUNTY COMMISSIONERS.
- C. THE MINUTES AND INDEXES SHALL BE THE OFFICIAL PUBLIC RECORD OF THE ACTS, ORDINANCES, AND RESOLUTIONS OF THE BOARD OF COUNTY COMMISSIONERS AND SHALL BE AVAILABLE FOR PUBLIC INSPECTION DURING THE NORMAL BUSINESS HOURS OF THE COUNTY GOVERNMENT.
- D. ANY ACT, ORDINANCE, OR RESOLUTION FILED AS REQUIRED SHALL BE ADMISSIBLE AS EVIDENCE IN ANY COURT PROCEEDING UPON CERTIFICATION BY THE CLERK OF THE BOARD OF COUNTY COMMISSIONERS.
- 55-2. EFFECTIVE DATES OF LEGISLATION.

AN ACT, ORDINANCE, OR RESOLUTION SHALL TAKE EFFECT ON THE DATE SET IN THE ACT, ORDINANCE, OR RESOLUTION.

CHAPTER 57 PARKS AND RECREATION, BOARD OF

57-1. ESTABLISHMENT; DIRECTOR.

THE BOARD OF COUNTY COMMISSIONERS OF CECIL COUNTY SHALL ESTABLISH A BOARD OF PARKS AND RECREATION AND A DIRECTOR OF PARKS AND RECREATION, WITH POWERS AND DUTIES AS SPECIFIED IN THIS CHAPTER.

57-2. COMPOSITION; TERMS; SERVICE WITHOUT COMPENSATION.

THE BOARD SHALL CONSIST OF EIGHT (8) MEMBERS, APPOINTED BY THE BOARD OF COUNTY COMMISSIONERS, OF WHOM EACH
