

APPROVAL OF THE BOARD OF COUNTY COMMISSIONERS, MAY BE BY PURCHASE, CONDEMNATION, GRANT, BEQUEST, DEVISE, OR LEASE OF THE FEE OR ANY LESSOR INTEREST, DEVELOPMENT RIGHT, ASSIGNMENT, COVENANT, OR OTHER CONTRACTUAL RIGHT NECESSARY FOR PARK AND RECREATION PROGRAMS. THE BOARD OF COUNTY COMMISSIONERS MAY SELL OR IN ANY MANNER DISPOSE OF THESE PARKS AND RECREATIONAL PROPERTIES.

57-5. COMPREHENSIVE PROGRAM OF PUBLIC RECREATION.

THE BOARD, SUBJECT TO BUDGETARY POLICIES AND APPROPRIATIONS OF THE BOARD OF COUNTY COMMISSIONERS, MAY ESTABLISH, ADOPT, DIRECT, OR CAUSE TO BE CONDUCTED OR DIRECTED A COMPREHENSIVE PROGRAM OF PUBLIC RECREATION IN SCHOOLS, PARKS, OR OTHER LANDS OR BUILDINGS, EITHER PUBLICLY OR PRIVATELY OWNED. IT FURTHER MAY DEVELOP, EQUIP, OPERATE, MAINTAIN, OR ISSUE PERMITS FOR THE USE OF ANY FACILITIES MADE AVAILABLE TO THE BOARD AND MAKE CHARGES WHERE APPROPRIATE. THE INITIATIVE FOR ALL PROGRAMS SHALL COME FROM THE GENERAL PUBLIC.

57-6. CONTROL OF LAND, BUILDINGS OR FACILITIES.

THE CONTROL OF ANY LAND, BUILDINGS, OR OTHER ACCEPTABLE FACILITIES SHALL BE IN ACCORD WITH AGREEMENTS REACHED BETWEEN THE BOARD AND THE PERSON, CORPORATION, OR AGENCY HAVING JURISDICTION OVER SUCH PROPERTIES. NO POWER OR AUTHORITY CONFERRED BY THIS CHAPTER SHALL BE CONSTRUED TO ABRIDGE OR LIMIT THE POWER OF THE BOARD OF COUNTY COMMISSIONERS, THE BOARD OF EDUCATION, OR OF ANY GOVERNMENTAL AGENCY, OR OF ANY PERSON OR CORPORATION, TO REFUSE TO PERMIT OR TO LIMIT THE USE OF ANY GROUND, BUILDING, OR FACILITY UNDER THEIR CONTROL, OWNERSHIP OR JURISDICTION.

57-7. INITIATION OR MAINTENANCE OF RECREATION PROGRAM.

THE BOARD, SUBJECT TO THE APPROVAL OF THE BOARD OF COUNTY COMMISSIONERS, MAY CONTRACT WITH PRIVATE ORGANIZATIONS FOR THE INITIATION AND MAINTENANCE OF PUBLIC RECREATION PROGRAMS.

57-8. ANNUAL REPORT OF ACTIVITIES TO COUNTY COMMISSIONERS.

THE BOARD SHALL SUBMIT TO THE BOARD OF COUNTY COMMISSIONERS AN ANNUAL REPORT OF ITS ACTIVITIES, TOGETHER WITH RECOMMENDATIONS FOR FURTHER ACTIVITIES AND DEVELOPMENT OF THE COUNTY RECREATION PROGRAM. IT SHALL ALSO SUBMIT AN ANNUAL BUDGET, PURSUANT TO THE REQUIREMENTS OF LAW, ITEMIZING THE APPROPRIATIONS NECESSARY FOR THE PERFORMANCE OF ITS FUNCTIONS AND DUTIES.
