WITHIN ANY MUNICIPALITY WATER, SEWERAGE AND DRAINAGE FACILITIES OF ANY INCORPORATED MUNICIPALITY SHALL NOT BE EXTENDED BEYOND THE CORPORATE LIMITS OF SUCH MUNICIPALITY WITHOUT THE EXPRESS APPROVAL AND AUTHORITY OF THE COUNTY, EXCEPT THAT SUCH APPROVAL SHALL NOT BE REQUIRED IN THE EVENT OF ANNEXATION BY SUCH MUNICIPALITY PURSUANT TO ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND.

- B. NOTHING IN THIS CHAPTER SHALL BE CONSTRUED AS IMPAIRING THE VALIDITY OF ANY BONDS ISSUED PRIOR TO JUNE 1, 1972, BY THE CECIL COUNTY METROPOLITAN COMMISSION AND GUARANTEED BY CECIL COUNTY, MARYLAND.
- C. IN EXERCISING THE POWERS GRANTED BY THIS SUBTITLE, THE COUNTY SHALL NOT BE SUBJECT TO THE PROVISIONS OF ANY PLANNING REGULATIONS OR ZONING ORDINANCES ENACTED UNDER THE PROVISIONS OF ARTICLE 66B OF THE ANNOTATED CODE OF MARYLAND.
- 67-2. JURISDICTION OF BOARD OF COUNTY COMMISSIONERS.

FOR THE PURPOSE OF CARRYING OUT THE PROVISIONS OF THIS SANITARY DISTRICT SHALL THE BE UNDER CHAPTER. AND OF THE COUNTY JURISDICTION CONTROL BOARD OF COMMISSIONERS OF CECIL COUNTY.

67-3. DIRECTOR OF SANITARY FACILITIES; DIRECTOR OF PUBLIC WORKS.

THE DIRECTOR OF PUBLIC WORKS OF CECIL COUNTY, APPOINTED PURSUANT TO THE PROVISIONS OF CHAPTER 60, PUBLIC WORKS, DEPARTMENT OF, OF THIS CODE SHALL BE THE CHIEF ADMINISTRATIVE OFFICER OF THE CECIL COUNTY SANITARY DISTRICT AND WILL SERVE IN SUCH CAPACITY UNDER THE TITLE OF DIRECTOR OF SANITARY FACILITIES. IT SHALL BE THE DUTY OF SUCH DIRECTOR TO EXECUTE THE POLICIES OF THE COUNTY WITHIN THE PROVISIONS OF THIS CHAPTER. THE DIRECTOR OF SANITARY FACILITIES SHALL APPOINT SUCH ENGINEERING, LEGAL, ADVISORY, CLERICAL AND OTHER PERSONNEL AS IN HIS JUDGMENT ARE NECESSARY FOR CARRYING OUT THE PROVISIONS OF THIS CHAPTER, AND SUCH PERSONNEL SHALL BE PAID AT SUCH WAGE OR SALARY SCALES AS MAY BE APPROVED BY THE COUNTY.

67-4. STATISTICAL AND FINANCIAL REPORTS TO COUNTY.

THE DIRECTOR OF SANITARY FACILITIES SHALL ANNUALLY, ON OR BEFORE THE FIRST OF JULY, PREPARE AND FILE A REPORT WITH THE COUNTY ON THE PHYSICAL PLANTS AND EQUIPMENT OF THE SANITARY DISTRICT, A STATEMENT OF THE ACTIVITIES OF THE SANITARY DISTRICT DURING THE PRECEDING FISCAL YEAR, AND A STATEMENT OF ACTIVITIES PROPOSED TO BE UNDERTAKEN DURING THE ENSUING
